The Board of the Morgan County Commissioners met in their office on Monday, May 3, 2004, with the following members present:

The meeting was called to order at 8:30am with the pledge of allegiance to the flag.

Minutes from the previous meeting were read and approved.

The Commissioners reported on their activities for the previous week. Commissioner Dodrill attended an arbitration meeting on Tuesday, May 4, 2004 and a Family and Children First meeting on Friday, May 7, 2004. All Commissioners attended the LEPC Board meeting at Deano's on Monday May 3, 2004. Commissioner Moore and Jeff McInturf from the Engineer's Office attended a Sprint Public Safety Seminar in Mansfield on Tuesday, May 4, 2004. On Friday, May 7, 2004 Moore attended Buckeye Joint County Self-Insurance Council meeting at Burr Oak State Park and the Workforce Development retreat in Marietta.

Terry Robison, Director of Morgan County EMA, presented additional information to the Commissioners concerning the Emergency Operations Center Special Project Grant. This grant can be worked in different sections and match monies will be needed for that particular section. After much discussion it was decided that, in light of this new information, to continue with the application process and try to become funded for the full amount of this grant of approximately \$61,000 with match monies of 50% spread over a 2 year period
