The Board of the Morgan County Commissioners met in their office on Monday, March 29, 2004, with the following members present:

The meeting was called to order at 8:30am with the pledge of allegiance to the flag.

Minutes from the previous meeting were read and approved.

The Commissioners reported on their activities for the previous week. Bruce Dozer attended the regular MOU meeting on March 22, 2004, in Marietta. On March 23, 2004, he attended the Council on Aging meeting at the Sr. Center, and on March 23, 2004 he attended the Planning Commission meeting in the Riecker Complex. Ron Moore met with the Board of Elections on Tuesday, March 23, 2004, attended the S.E. Ohio Regional Jail Commission meeting in Nelsonville on Wednesday, March 23, 2004, and, attended the Senior Citizens' Brunch at the Senior Center on Thursday March 25, 2004.

Tim Friedberg, 5118B Doe Run Lane, Missouri shared his concern of taxes not being paid on production of oil wells. He estimates an amount due to be as high as \$28,000 and ranges back as far as 1981. He has approached the County Treasure about this problem and is awaiting information back from the Treasurer.

Jeff Shaner of OSU Extension & Economic Development, reported Congressman Ney should approve the road improvement for Twp. 209 soon. This will be a 3.3 million dollar improvement for Twp. 209. He also reported the CIC has the commitment of \$10,000 for match funds to GOA., for Telecommuncations Study.

Dan Richardson, Recycle and Litter Prevention, turned in his weekly Activity Time Sheet and reminded the Commissioners that his work hours have changed to 6:00 a.m. to 2:30 p.m. due to softball starting. A meeting at the Yard Waste site on Twp. Road 209 proved that Morgan County has a mulching site and not a compost site, so the site, is not governed by compost regulations.
