

## **Morgan County Commissioners Riecker Building**

The Board of the Morgan County Commissioners met in their office on Monday, November 8, 2004, with the following members present:

The meeting was called to order at 8:30 a.m. with the pledge of allegiance to the flag.

Congratulations were extended to Dean Cain and Rick Shriver on their success in winning the election for Commissioners.

Commissioners reported on their activities for the week: Commissioner Moore participated in the Issue 11 subcommittee meeting at the Riecker Complex on Monday. On Wednesday, Commissioner Moore attended a meeting with ODOT officials and representatives from the Washington-Morgan Community Action Agency at the Riecker Complex. Thursday, Commissioner Moore attended a Meigs Watershed meeting at the Riecker Complex. Also on Thursday he met with Gary Williams and Jody Murray from Washington State Community College and Amy Grove from OSU Extension to discuss the Community College Consortium.

Commissioners discussed the construction of a replacement building for the structure that burned in Malta.

Commissioners discussed having the Morgan High School Carpentry Class to build a 6' x 8' ft. building for the storage of a snow blower and push mower at the Riecker Building. Commissioner Dozer will talk to Jamie White about the project.

Jeff Shaner, OSU Extension Director of Economic Development, reported the E-Z Grout Company has met and exceeded the qualifications for justifying the Morgan – Meigs Water District \$500,000 grant which was obtained from the Department of Development. The qualifications were to employ 24 people. The E-Z Grout Company has employed as many as 28 people. Congratulations were extended to this new Morgan County company.

Gary Woodward, Morgan County Auditor, discussed the lack of money in the Treasurer's budget to continue the operation of the office for the remainder of the year.

Dan Richardson, Recycling and Litter Prevention, turned in his time sheet, two leave requests, and a meeting request. He also reported that everything is ready for a productive Litter Summit on Tuesday, November 9, 2004, in the Riecker Building.
