The Board of the Morgan County Commissioners met in their office on Monday, October 4, 2004, with the following members present:

The meeting was called to order at 8:30 a.m. with the pledge of allegiance to the flag.

The Commissioners reported on their activities for the week of October 4: All Three attended the Morgan County Planning meeting on Tuesday. Commissioner Moore participated in a meeting involving Washington State Community College and six other institutions of higher education. The meeting was held at the First National Bank and centered on the planning for a consortium of educational institutions serving within Morgan County. Commissioner Moore also attended the OSU Extension Advisory Board meeting on Thursday. Commissioner Dozer installed an exhaust fan in the kitchen of the Sr. Center.

Jeff Shaner, OUS Extension and Economic Development reported that Mr. Perry Varnadoe, the new Regional 11 Representative for the Governors' Office, Department of Development, begins his duties today. After reviewing the goals of Habitat, the steps for Affiliate status, and discussing the responsibilities of our Steering Committee, it was agreed that the Committee was ready to submit the information needed to Regional Manager, Rosemary Koly, to obtain Affiliate status.
