

## **MORGAN COUNTY COMMISSIONERS RIECKER BUILDING**

The Board of the Morgan County Commissioners met in their offices on Monday, April 24, 2006 with the following members present:

The meeting was called to order at 8:30 am with the pledge of allegiance to the flag. The minutes of the April 17, 2006 meeting were read and approved.

**06-199** Motion by Mr. Ron Moore and seconded by Mr. Dean Cain to approve the minutes from April 17, 2006.

The commissioners reported on their activities from the preceding week of April 17, 2006.

On Monday, Commissioner Cain met with Judge Lowe regarding the Department of Criminal Justice meeting and also met with Judge Favreau and Mark Howdysshell regarding keeping the Off-Site Campus Learning Center at the courthouse.

On Monday evening Commissioners Moore and Cain took the three remaining ISO classes as directed by the Federal Emergency Management Agency.

On Tuesday, Commissioner Moore met with Larry Hivnor from the Ohio Valley Employment Resources office to discuss Workforce Investment Act issues.

The commissioners along with representatives from the engineer's office, the sheriff's office, the EMA, and the M & M Fire Department met on Wednesday with Sprint officials to discuss E-9-1-1 upgrades, mapping, reverse 9-1-1, and wireless 9-1-1. Also on Wednesday, Commissioners Shriver and Moore attended the Chamber of Commerce meeting at the River Queen. Commissioner Shriver took Mr. Andy Fang to the Chamber meeting as a new business person in town. Also on Wednesday, Commissioner Shriver met with the auditor and Shannon Wells, Development Office regarding grant administration fees.

On Thursday, the commissioners attended the Planning Commission's Public Information meeting to discuss subdivision rules. Commissioners Moore and Cain met with John Lanning of RHS Solutions and David Couch, MRDD director to discuss workers' compensation and injury prevention. Also on Thursday, Commissioner Cain met with Judge Favreau and Mike Totman regarding litter clean up in the county.

On Friday, Commissioner Cain met with Judge Lowe to arrange community workers performing litter clean up in the county.

On Saturday, Commissioner Cain attended the Neelyville Grange banquet.

Mr. John Sampson, Morgan County Transit, reported on the transit program. Mr. Sampson stated that two-way radios will be installed in the vans on Wednesday. Mr. Sampson also reported that they have received a lot of positive feedback from clients.

Mr. Sampson submitted data sheets reflecting the numbers of clients, service hours, contract miles and contract hours the transit program has completed for the month to date. According to the report, as of April 21 a total of 39 Elderly disabled, 17 general service riders, 16 contract elderly disabled and 8 other riders have used the program. A total of 556.5 general service miles and 663 contract miles had been driven with a total of 26.75 general service hours and 24.5 contract hours being reflected.

Commissioner Shriver asked if the transit buses could be chartered. Mr. Sampson stated that the MRDD buses could be chartered and that the insurance company is being contacted regarding this.

Mr. Sampson reported that one of the buses is currently out of service because of a cracked frame. He reported that he is currently in the process of obtaining several estimates to get the bus repaired.

Mr. Jeff Shaner, OSU Extension Office, reported that the Extension Advisory meeting will be held on Monday April 25, 2006. Mr. Shaner wanted to clarify the information on the Ag Marketing Grant. Mr. Chris Penrose is the faculty member representative for the grant. Mr. Penrose will be the person handling this project and ensuring its success. He will be using the grant for the promotion for the Farmers' Market.

Mr. Shaner reported that the Entrepreneur Support Network meeting will be held on Tuesday April 25, 2006.

Mr. Shaner met with Senator Voinovich and discussed economic development in the county. Mr. Shaner also spoke with T.J. Justice, Governor's Office of Appalachia, regarding the broadband project in Chesterhill.

**06-200** Motion by Mr. Ron Moore and seconded by Mr. Dean Cain to approve a request to establish fund 113 for Morgan County Public Transit and to approve a supplemental appropriation of \$6,000.00 for line item 113-0113-5102.00 salaries for a total appropriation of \$38,610.00 as submitted by Mr. David Couch, Superintendent.

The commissioners left the office at 9:15 AM for the public viewing of Co. Rd. 5 and Co. Rd 11 north.

The commissioners stated that they needed to correct the April 17, 2006 minutes to reflect that the Family & Children First Office is at Morgan Metropolitan Housing, not the Health Department building, as reported.

The commissioners returned to the office at 10:15 AM.

Mr. Robert Moore and Mr. Duane Hostetler stopped by the commissioners' office and presented a product called MPG-CAPS Fuel Conditioning which will increase fuel mileage on both gas and diesel vehicles. The fuel additive not only increases fuel mileage, but it will also clean engines and reduce emissions.

Commissioner Moore suggested that Mr. Moore and Mr. Hostetler share this information with the engineer's office and sheriff department as they are the largest users of fuel.

The commissioners are in receipt of a letter from Mr. David Couch on behalf of the Family and Children First Council. The letter acknowledges receipt of a letter from the commissioners regarding a personnel committee for the Family and Children First Council. Mr. Couch states that he will activate the committee as the commissioners letter suggests and direct them to fulfill the requirements as noted.

Mr. Jim Ridenour, Director, Job and Family Services, submitted meeting requests for Cathy Apperson and Kay Drabik to CRIS-E training on May 18<sup>th</sup> and 19<sup>th</sup> in Zanesville and for JoAnn Bloomfield, Katie Mansperger and Sid Richardson to CRIS-E Training May 11<sup>th</sup> and 12<sup>th</sup> in Zanesville.

Mr. Ridenour also submitted the Summer Youth Employment and Training Contract with Community Action. The contract will be in effect from May 1, 2006 through September 30, 2006. The total reimbursement expenditures for the contract period shall not exceed \$112,466.00 payable at the start of the program. Washington-Morgan Community Action Corp. can only be reimbursed for services given to program participants. Any remaining funds are to be sent to the Morgan County Department of Job and Family Services and no additional fees may be charged to the consumer for services rendered under this contract.

Mr. Ridenour reported that through the selection process, it was decided that Ms. Heidi Burns should be selected for the Fiscal Officer position. Ms. Burns currently holds the Account Clerk 2 position and has been with Job and Family Services for 5 years. She will begin the new position on May 1, 2006.

The commissioners are in receipt of an Application to Cross Public Road submitted by Sprint. Sprint is requesting permission to bore under Cordray Rd CR 98, bore under

TWP 100, bore under St Rt 37 and place wires along St Rt 37, and place wires along CR 3 located in Malta Township. The crossing is for the installation of a 3 inch diameter telephone fiber. The construction will begin on or about June 1, 2006 and will be completed by September 1, 2006.

The commissioners entered into a maintenance agreement with Central Ohio Coal, Co. the maintenance agreement will begin on May 1, 2006 and continue through April 30, 2007 on both roads.

Mr. Stevan Hook, Engineer, reported on the work being done on CR 84.

The commissioners are in receipt of a request from Mr. Jim Wilson, Morgan County Republican Central Committee Vice-Chairman, to hold a political rally on the courthouse lawn on May 1, 2006 from 5:00 PM to 7:00 PM. Permission was granted.

The commissioners signed an Agreement for 2006 Litter Collection and Disposal Services. This agreement is between the Board of Directors of the Southeastern Ohio joint Solid Waste Management District and the Morgan County Commissioners and is for

a grant in the amount of \$2000 to assist the county's performance of roadside litter collection activities.

The commissioners are in receipt of a request from Ms. Pamela Montgomery, Extension Educator 4-H/FCS to have to 4-H Junior Leaders clean the flower beds in front of the Riecker Building. The scheduled date for clean up is May 9, 2006 from 5:30 to 7:00 PM.

The commissioners are in receipt of the Revised TANF Allocation submitted by Department of Job & Family Services for the time period of July 1, 2005 through June 30, 2006. The amounts of the allocations are: \$1,005,664; \$83,761; \$408,650; \$9,905; \$120,000; \$305,253 and \$152,006.

Ms. Darla Wooten, Pitney-Bowes, presented pricing to the commissioners for a new postage machine. The contract on the postage machine located in the clerk of courts office will expire and a new contract issued. Ms. Wooten offered a newer machine for only \$1.00 additional per month. The commissioners entered into a contract with Pitney-Bowes for a newer machine.

Commissioner Moore was excused at 2:30 PM.

Mr. Jeff Driggs, County Dog Warden, submitted his report and mileage sheet for the week of April 22, 2006. Mr. Driggs reported he drove a total of 232 miles and picked up 6 dogs. This week 6 dogs were destroyed. Mr. Driggs reported that currently at the pound he is holding a female schnauzer that is available for adoption. He asked the commissioners to have anyone interested in adopting this dog call 962-6424.
