

**MORGAN COUNTY COMMISSIONERS

The Board of the Morgan County Commissioners met in their offices on Tuesday January 3, 2006 with the following members present:

The meeting was called to order at 8:30 am with the pledge of allegiance to the flag. The minutes of the December 27, 2005 meeting and the special budget meeting minutes held December 30, 2005 were read and approved.

06-001 Motion by Mr. Rick Shriver and seconded by Mr. Dean Cain to approve the minutes from the December 27th meeting and the special budget meeting held December 30, 2005.

Ms. Shannon Wells, Grant Administrator, reported on the budget for the year 2006 for the grant office. Ms. Wells also discussed changing the name from Grant Office to Community Development Office. After a brief discussion, it was decided that the office will be known as the "Morgan County Commissioners' Development Office" in place of "Grant Office".

Mr. Jeff Shaner, OSU Extension Office, reported on the Ohio Fair Managers Convention being held this week. Mr. Chris Penrose will be attending along with 16 4-H youth. Mr. Shaner also reported that the 4-H Horse Committee will meet January 3 and the Livestock Committee will meet Thursday January 5 to make plans for 2006. Mr. Shaner also reported the CIC will meet next week in the Chamber Room.

Mr. Shaner reported on January 20th the State Extension Office will be conducting a seminar on "Working with People in Poverty" for extension employees.

Mr. Stevan Hook, Engineer, reported on the fuel bid results. Two vendors submitted bids for supplying regular unleaded gasoline, high-sulfur #2 diesel fuel, and low-sulfur#2 diesel fuel for the county highway department, sheriff, auditor, litter control and several townships.

The bids are based upon the Marietta "Oil Price Information Service" (OPIS) for the date of delivery to the customer's tank or designated location. This means that the base price and taxes are the same for both vendors which means that only the delivery cost is the variable.

Mr. Hook reported that after careful review, it is his recommendation that the fuel contract be awarded to Greuey's Fuel.
