On Thursday, Commissioner Cain met with Sheriff Jenkins regarding the housing of prisoners.

On Friday, Commissioner Moore attended the Morgan County Family and Children First Council meeting at the Malta United Methodist Church. Also on Friday, Commissioner Cain attended the County Sub Committee meeting that was chaired by Engineer Stevan Hook.

The commissioners passed the following resolution to be placed on the May primary. A copy of this resolution was certified to the Board of Elections.

RESOLUTION 06-099

A RESOLUTION TO PLACE AN ADDITIONAL TAX LEVY IN THE AMOUNT OF 1.28 MILLS UPON THE MAY 2, 2006 PRIMARY ELECTION BALLOT FOR THE BENEFIT OF THE MORGAN COUNTY BOARD OF MENTAL RETARDATION AND DEVELOPMENTAL DISABILITIES

WHEREAS, the Morgan County Board of Mental Retardation and Developmental Disabilities have requested of the Morgan County Commissioners and additional sum of \$305,000 per year, for the tax years 2006, 2007, 2008, 2009, 2010, and 2011, to provide programs and services for persons with mental retardation and

developmental disabilities and provide for the acquisition, construction, renovation, financing, maintenance, and operation of mental retardation and developmental disabilities facilities. (Programs, services and facilities provided by the Morgan County Board of Mental Retardation and Developmental Disabilities are commonly called the "Mary Hammond Program" but are separate and distinct from the legal entity known as "Mary Hammond Adult Activity Center, Inc. which operates a sheltered workshop and contracts with the Morgan County Board of Mental Retardation and Developmental Disabilities to provide services to persons with mental retardation and developmental disabilities); and

WHEREAS, it is the determination of the Morgan County Board of Commissioners that a levy is necessary to raise additional monies for the operation of programs and services by the Morgan County Board of Mental Retardation and Developmental Disabilities as defined in ORC 5123 and 5126 and for the acquisition, construction, renovation, financing, maintenance, and operation of mental retardation and developmental disabilities facilities, and that the amount of taxes that may be raised within the ten mill limitation are insufficient to provide the funding necessary for the Morgan County Board of Mental Retardation and Developmental Disabilities to provide the programs and services for persons with mental retardation and developmental disabilities and provide for the acquisition, construction, renovation, financing, maintenance, and operation of mental retardation and developmental disabilities facilities; and

WHEREAS, the Morgan County Board of Commissioners determines that the amount of additional funds necessary to provide the programs and services for persons with mental retardation and developmental disabilities and provide for the acquisition, construction, renovation, financing, maintenance, and operation of mental retardation and developmental disabilities facilities operated by or contracted through the Morgan County Board of Mental Retardation and Developmental Disabilities is \$305,000 per year, for the tax years 2006, 2007, 2008, 2009, 2010, 2011; and

WHEREAS, the Morgan County Auditor has determined that the estimated property tax millage necessary to produce \$305,000 per year is 1.28 mills for each one

dollar of tax valuation; now therefore

BE IT RESOLVED, that in accordance to the provisions of §5705.19 R.C. and

§5705.222 R.C. the Board of County Commissioners of Morgan County declares it

necessary to levy an additional tax in excess the ten mill limitation of levies, to provide

programs and services for persons with mental retardation and developmental disabilities

and provide for the acquisition, construction, renovation, financing, maintenance, and

operation of mental retardation and developmental disabilities facilities operated by or

contracted through the Morgan County Board of Mental Retardation and Developmental

Disabilities (Programs, services and facilities provided by the Morgan County Board of

Mental Retardation and Developmental Disabilities are commonly called the "Mary

Hammond Program" but are separate and distinct from the legal entity known as "Mary

Hammond Adult Activity Center, Inc. which operates a sheltered workshop and contracts

with the Morgan County Board of Mental Retardation and Developmental Disabilities to

provide services to persons with mental retardation and developmental disabilities) and

submit to the electors an additional tax levy; and

BE IT RESOLVED, that such additional levy shall be at a rate not exceeding

1.28 mills for each one dollar of tax valuation which amount to 12.8 cents for each one

hundred dollars of tax valuation for six (6) years commencing with the tax year 2006; and

BE IT RESOLVED, that the Board of Elections of Morgan County, Ohio be and

is hereby directed to submit this issue to such election to be held on May 2, 2006, said

date being the spring primary election; and

Mr. Shaner reported that he and Mr. Mike Workman from the CIC will be visiting existing Morgan County businesses.

The Morgan County area 4-H clubs are starting to organize. Enrollment deadline is April 1, 2006.

Mr. Shaner also reported that the Entrepreneur Support Network will be on February 21, 2006 from 9:30 – 11:00 AM. The topic will be "Marketing Products on E-Bay." Sponsoring agencies are OSU Extension, Rural Action, and Small Business Development Centers.

Ms. Kathy Potteiger, Family & Children First, submitted invoices for payment.

State Representative Jimmy Stewart stopped by the commissioners' office. Commissioner Moore spoke to him about the concerns of the county regarding the funding cuts to the child support system.

Commissioner Shriver commended Representative Stewart for the statements he was quoted as making in Time Magazine. During the interview with Time Magazine, Representative Stewart stated that the state of Ohio should spend TANF funds instead of "just sitting on them."

The commissioners are in receipt of the Monthly Statement of Number of Meals Served. This report reflects 290 meals served to prisoners during the month of January.

Mr. Jim Ridenour, Director, Job & Family Services, submitted the revised Prevention, Retention and Contingency (PRC) Plan to update to the new Federal Poverty Guidelines. The PRC program is designed to meet the four purposes of the Federal TANF Program. The four areas are:

- 1. To provide assistance to needy families so that children may be cared for in their own homes or in the homes of relatives;
- 2. To end the dependence of needy parents on government benefits by promoting job preparation, work and marriage;
- 3. To prevent and reduce the incidence of out-of-wedlock pregnancies and establish annual numerical goals for preventing and reducing the incidence of these pregnancies;
- 4. To encourage the formation and maintenance of two-parent families.

PRC services are not ongoing TANF assistance. PRC services are one-time, short-term non-recurrent "non assistance" benefits and services.

Ms. Linda Sheets, Director, Office on Aging, submitted invoices for payment.

The commissioners submitted the revised annual budget and financial reports required by the United States Department of Agriculture Rural Development, Marietta Office.

Mr. Kevin Lewis, Ohio LECET, reported to the commissioners he is now representing the unions in 20 southeastern Ohio counties. He is currently visiting all of the county commissioners in those counties to explain the assistance he can provide. Mr. Lewis stated that he will be conducting random audits of various county prevailing wage records to ensure that counties are in compliance. He also offered his assistance with providing the commissioners with information on union contractors such as prevailing wage compliance and safety records.

Mr. Larry Hivnor, O.V.E.R., gave the commissioners an update on the Workforce Investment Act activities.

Ms. Mary Gessel, Clerk of Courts, reported to the commissioners that the title office will have to close a half day per week beginning in March. She stressed the importance of her office remaining open. The commissioners explained to her that the county simply does not have the funds available to keep her office open 5 days a week and she would have to simply make cuts where needed.

Ms. Shannon Wells, Community Development Office, reported on the Health Department project. She will contact Pat Kelly, Architect for plans and bid documents. The commissioners committed to go forward with this project and will be known as the

Health Center Renovation Project. This project will be funded using funding from the ARC Grant and the Osteopathic Foundation.

At 1:30 P.M. the commissioners held the bid opening for the Stockport Volunteer Fire Department. The only bidder was Finley Fire Department.
