

**MORGAN COUNTY COMMISSIONERS
RIECKER BUILDING**

The Board of the Morgan County Commissioners met in their offices on Monday, May 7, 2007 with the following members present:

Rick Shriver, President
Dean Cain, Vice-President
Don Reynolds, Member

The meeting was called to order at 8:30 am with the pledge of allegiance to the flag. The minutes of the April 30, 2007 meeting were read and approved.

06-772 Motion by Mr. Dean Cain and seconded by Mr. Don Reynolds to approve the minutes from April 30, 2007.

Commissioners reported on their activities for the week April 30, 2007.

Commissioner Dean Cain and Rick Shriver attended the Farm Bureau breakfast on May 2, 2007.

Commissioner Dean Cain met with Terry McGrew, Director, Health Department, concerning problems with the sewer system on May 3rd. On May 4th, Mr. Cain attended the Welcome Home Parade and the ceremony at the Armory for the returning troops. Mr. Cain also met with Jimmy Stewart, Ohio House of Representatives, on May 4th.

Commissioner Rick Shriver traveled to Columbus and met with the governor's chief information officer, director of the Ohio Super-computer Center, policy staff from the governor's office and staff from Congressman Zach Space's office to discuss wireless broadband initiatives for Appalachian Ohio on April 30th. On May 5th, Mr. Shriver met with United Way of Perry, Muskingum and Morgan counties nominating committee.

Steve Hook, Engineer, discussed the formula for Worker's Compensation. Commissioners contacted John Lanning, RHS Solutions, for clarification. Mr. Hook inquired if last year's bid would be accepted by commissioners from Shelly & Sands to repair County Road 10. Commissioners agreed because it will save the county money. Mr. Hook noted DDTI will begin road centerline and home addressing for GPS coordinates next week.

Amy Grove, Tourism, discussed making cleaning supplies available for Riecker Community Room renters and noted scheduling for the Chamber room needs to be directed to her and she will give out keys. Ms. Grove discussed restoration and the preservation of the Opera House. A community meeting will be held by the end of May with an architect. Ms. Grove noted the Tourism Advisory Committee discussed the county wide lodging tax. This would create dollars for additional marketing for the county. Ms. Grove discourages roadside spraying specifically near the scenic byway and commented on a petition to District 10 concerning this.

Mike Totman, Court Administrator, discussed medical providers leaving the insurance network.

Jim Ridenour, Department of Job and Family Services, submitted a meeting request for Kari Krause to Adoption Assessor Training on June 1st, in Athens. Mr. Ridenour submitted a supply request for toner cartridges for Resource Room and a supply request for day care items. Mr. Ridenour discussed the COG meeting on May 18th.

John Kitts, Jerry White, George Harman, Veterans Service Office, and Jim Forster, Deputy Director, Governor's Office of Veterans Affairs, provided an update on the attended State Convention on April 13th - 15th and discussed the budget for their office. Mr. Kitts noted there is a nationwide backlog of 600,000 claims and a new compensation claim can take 14 to 18 months to process. Ms. Della Bratton sat in on the conversation and asked the Veterans Service Office why this is acceptable treatment of our Veterans. Commissioners encouraged the Veterans Service Office to contact Congressman Zack Space to voice their opinions about the treatment of our Veterans.

Commissioners gave the Veterans Service Office their 5/10 mil.

Commissioners signed a Proclamation, submitted by Linda Sheets, Office on Aging, declaring May 15, 2007 as "Senior Citizen Day." Lunch will be provided at 11:30am at the Riecker Building Nutrition site and a program at the Opera House to follow at 1:00pm.

Commissioner Rick Shriver signed a Contract (Chapter 5521, Ohio Revised Code), between the State of Ohio, Department of Transportation and the Board of Morgan County Commissioners for the rehabilitation of existing 73' single span covered bridge.

Commissioners are in receipt of a letter submitted by Thomas Jenkins, Sr., Sheriff, concerning the Morgan County Jail usage in April 2007 to reduce costs at the Southeastern Ohio Regional Joint Jail. The total bed days for the month of April 2007 are 157 and meals would be more due to the additional prisoners. This count is prisoners held here for at least one day each and other prisoners were also brought for court and returned, which are in addition to these figures.

The following Final Resolution enacted by the Board of County Commissioners, Morgan County, hereinafter referred to as the Legislative Authority/Local Public Agency (LPA), in the matter of the stated described project.

WHEREAS, on the **12th day of April, 2004**, the LPA enacted legislation proposing cooperation with the Director of Transportation for he described project:

Rehabilitation of existing 73' single span covered bridge, including the addition of two glue laminated timber arches and beams to carry the existing bridge. New siding, roof and floor system, lying within Morgan County.

WHEREAS, the LPA shall cooperate with the Director of Transportation in the above described project as follows:

The County agrees to assume and bear one hundred percent (100%) of the entire cost of the improvement, less the amount of Federal-aid and State funds set aside by the Director of Transportation for the financing of this improvement from funds allocated by the Federal Highway Administration, U.S. Department of Transportation, and further, the County agrees to assume and bear one hundred percent (100%) of the cost of Preliminary Engineering and Right-of-Way, excluding in-house preliminary engineering and Right-of-Way charges incurred by the State.

Also, the County agrees to assume and bear the entire cost and expense of the installation and/or repair of curb ramps which are necessary to ensure compliance with the Americans with Disabilities Act.

In addition, the County also agrees to assume and bear one hundred percent (100%) of the cost of any construction items requested by the County on the entire improvement, which are not necessary for the improvement, as determined by the State and Federal Highway Administration.

In view of the fact that the LPA's share of the project is now estimated in the amount of **Zero and - - - 00/100 Dollars (\$0.00)** therefore, the County will not be required to deposit any funds at this time. The LPA's ultimate share of the cost will be determined when final actual costs and allocations are determined.

WHEREAS, the Director of Transportation has approved said legislation proposing cooperation and has caused to be made plans and specifications and an estimate of cost and expense for improving the above described highway and has transmitted copies of same to this legislative authority; and

WHEREAS, This legislative authority desires the Director of Transportation to proceed with the aforesaid highway improvement.

NOW, THEREFORE, be It resolved:

- I. That the LPA hereby requests the Director of Transportation to proceed with the aforesaid highway improvement.
- II. That the LPA enter into a contract with the State, and that **President** be, and is hereby authorized to execute said contract for improving the described project.
- III. That the LPA transmit to the Director of Transportation a fully executed copy of this Resolution.
