The Board of the Morgan County Commissioners met in their offices on Monday, April 9, 2007 with the following members present:

The meeting was called to order at 8:30 am with the pledge of allegiance to the flag. The minutes of the April 2, 2007 meeting were read and approved.

**06-727** Motion by Mr. Dean Cain and seconded by Mr. Don Reynolds to approve the minutes from April 2, 2007.

Commissioners reported on their activities for the week April 2, 2007.

Commissioner Dean Cain attended the Insurance Committee meeting on April 3, 2007.

Commissioners Dean Cain and Don Reynolds attended the 37/78 Corridor Steering Committee meeting on April 5, 2007.

Commissioners are in receipt of a letter requesting the release of marriage license fees and divorce/dissolution fees that are due for the First Quarter of 2007, as submitted by Barbara Davis, Executive Director, Transitions, Inc.

Jeff Shaner, OSU Extension Office, and Melissa Zoller, Buckeye Hills- Hocking Valley Regional Development District, held the 2<sup>nd</sup> Public Hearing for the Phase II Clean Ohio Assistance Fund. Mr. Shaner noted that all requirements have been met for the 45 day period.

Jeff Shaner, OSU Extension Office, noted the Morgan County Community Improvement Corporation meeting will be held April 11, 2007 and the Second Advisory Committee for 37/78 Corridor will be held April 13, 2007.

Rob Reiter, Southeastern Ohio Joint Solid Waste, discussed illegal dumping of furniture and appliances at the Yard Waste Compost Site.

Commissioner Rick Shriver signed a CDBG Contract B-W-06-053-1 West Malta Rural Water District, as submitted by Melissa Zoller, Buckeye Hills- Hocking Valley Regional Development District, for the delegation of administering activities under a Community Development Block Grant from the Ohio Department of Development.

Jim Ridenour, Department of Job and Family Services, submitted a meeting request for Cheryl Bailey to CORE Module VIII Training on April 18, in Athens and submitted the Summer Youth Employment and Training Contract with Community Action to be signed by Commissioners. Mr. Ridenour submitted a

mandated share request, a supply request, and inquired if county offices were closed at noon on April 6, 2007. Commissioners informed Mr. Ridenour that all county offices were open but some elected officials chose to close their offices early. Mr. Ridenour submitted applications received for the Department of Job and Family Services Director position.
