

**MORGAN COUNTY COMMISSIONERS
RIECKER BUILDING**

The Board of the Morgan County Commissioners met in their offices on Monday, July 7, 2008 with the following members present:

Don Reynolds, Vice-President
Rick Shriver, Member

The meeting was called to order at 8:30 am with the pledge of allegiance to the flag. The minutes of the June 30, 2008 meeting were read and approved.

Commissioners reported on their activities for the week June 30, 2008.

On Monday, Commissioner Shriver met with the Morgan County Chamber of Commerce Community Festival committee to finalize plans for the July 4th Festival.

On Tuesday, Commissioners Reynolds and Shriver attended a meeting with U.S. Senator, Sherrod Brown, at Miba Bearings, Inc. Senator Brown met with several community leaders to obtain input of issues of local concern.

On Wednesday, Commissioner Shriver met with Don Barber, Deputy Director of Ohio Department of Transportation District Five, David Johansen, Engineer in ODOT District Five, and Stevan Hook, Morgan County Engineer to view and discuss the poor condition of State Route 60 from the Morgan County/Muskingum County line north to Duncan Falls.

On Saturday, Commissioner Cain met with the Morgan County Historical Society for a tour of the Courthouse.

On Saturday, Commissioner Shriver presented a proclamation from Governor Strickland on the occasion of the 150th anniversary of the construction of the Morgan County Courthouse.

Commissioners are in receipt of the statement from the Morgan County Sheriff's Office concerning jail usage for June 2008. To reduce costs at the Southeastern Ohio Regional Jail, a total of 113 prisoners were housed. This count is prisoners held here for at least one day each. Other prisoners were also brought for court and returned to Nelsonville, which are in addition to these figures.

Vicki Quesinberry, Director, Job and Family Services, submitted meeting request for Cathy Apperson to "Business Intelligence Channel- Computer System Training", in Columbus, on July 24th. Ms. Quesinberry submitted a Fiscal Consulting/Training Agreement between Morgan County Department of Job and Family Services and Chris Innis, to be signed by Commissioners.

Stevan Hook, Morgan County Engineer, submitted pictures displaying progress in the restoration of the Helmick Covered Bridge.
