The Board of the Morgan County Commissioners met in their offices on Monday, December 8, 2008 with the following members present:

The meeting was called to order at 8:30 am with the pledge of allegiance to the flag. The minutes of the December 1, 2008 meeting were read and approved.

Commissioners reported on their activities for the week December 1, 2008.

On Wednesday, Commissioner Cain attended the Morgan County Community Improvement Corporation meeting.

On Thursday, Commissioner Cain attended the Drug Free Workplace- Train the Trainer meeting, in Columbus.

Commissioners granted permission for David R. Hill Inc., to bore under County Road 106, located in Meigsville Township, Section 13, Morgan County, Ohio for a three inch diameter gas line. Construction of this project will begin on or about December 18th, 2008 and will be completed by December 19th, 2008. Commissioner Shriver abstained.

Judge Favreau, Common Pleas Court, discussed the Prosecutor's and Clerk of Courts budgets and the need for additional appropriations.

The following Board of Election members were present to discuss their current budget situation: Miranda Mullen, Director, Louise Pennock, Member, James Wilson, Chairman, Mary Anna Wallace, Member, Azcal Wilson, Member. Ann Block, Field Liaison, Secretary of State's Office, and Brian Shinn, Legal Counsel, Secretary of State's Office, were also in attendance. Commissioner Cain explained the county has no money.

Cost estimates were received from: DJH Computers, Staples, and Circuit City, for new computers for Transit. Commissioners authorized Mrs. Wells to proceed with the cost estimate from DJH Computers. Commissioners and Mrs. Wells discussed developing a list of economic development projects for the Federal Stimulus Plan for Buckeye Hills Hocking Valley Regional Development District.
