The Board of the Morgan County Commissioners met in their offices on Monday, August 17, 2009 with the following members present:

The meeting was called to order at 8:30 am with the pledge of allegiance to the flag. The minutes of the August 10, 2009 meeting were read and approved.

09-385 Motion by Mr. Dean Cain and seconded by Mr. Don Reynolds to approve the minutes from August 10, 2009.

Vote Don Reynolds- yea, Mike Reed- yea, Dean Cain- yea. Motion Carried

Becky Thompson, Dog Warden, reported traveling 83.4 miles responding to dog calls. Mrs. Thompson stated S.P.O.T. took 1 dog, 4 dogs were picked up, and 1 dog was redeemed, 8 dogs are currently in the pound, 3 dogs were euthanized.

Cassidy McGrew, Deputy Dog Warden, reported traveling 133.2 miles responding to dog calls, 3 dogs were picked up.

Jeff Howell requested permission to walk alongside County Road 11. Commissioners stated they couldn't give Mr. Howell permission, but suggested he speak with the Prosecutor, Mark Howdysshell.

Gary Woodward, Auditor, discussed appropriations per department, levies on the November ballot, and the Southeastern Ohio Regional Joint Jail.

09-388 Motion by Mr. Don Reynolds and seconded by Mr. Mike Reed to approve the following: be it hereby resolved that it is the intent of the Morgan County Board of Commissioner's to place an additional 0.8 mill levy upon the taxable lands of Morgan County, Ohio for the purpose of paying the

general expenses of the Morgan County Health Department. Said levy to be placed on the ballot of the November 3, 2009 general election to be approved or disapproved by a majority vote of the voting electorate.

A Public Hearing was held in the Commissioner's Office at 11:00am, for the Transit Grant application. The application is due September 4th. Those in attendance Commissioner Dean Cain, Don Reynolds and Mike Reed, Andrea Plummer, Commissioner's Clerk, and Shannon Wells, Morgan County Commissioners' Development Office.

09-389 Motion by Mr. Don Reynolds and seconded by Mr. Mike Reed to vacate County Road 97A, being located in Meigsville Township Section 13, in the platted town of Unionville. Beginning at the intersection of County Road 11 (Unionville Road) and County Road 97 A/ Township Road 672 (Stegner Lane), thence in a northeasterly course, along the centerline of what is known as Township Road 672 0.04 mile to the intersection of Township Road 342. It is intended to vacate all of County Road 97A for 0.04 and transfer to Meigsville Township.

WHEREAS, it is the determination of the county commissioners that the amount of tax within the mill limitations of levies on the current tax duplicate will be insufficient to provide the necessary requirements of the Morgan County Office on Aging in Morgan County, therefore,

BE IT RESOLVED, that in accordance with the provision of O.R. C. Section 5705.19 the Board of County Commissioners of Morgan County hereby declare it necessary to levy a tax in excess of such limitations for the purpose of providing for continuation of services to Senior Citizens through the Morgan County Office on Aging and expanding home care to the electors this renewal levy.

BE IT FURTHER RESOLVED, that such renewal levy shall be at a rate not exceeding 3/10th (0.3) of one mill for each one dollar (\$1.00) of tax valuation which amounts to three cents for each one hundred dollars (\$100) of tax evaluation for a period of five (5) years commencing tax year 2010.

BE IT FURTHER RESOLVED, that the Board of Elections of Morgan County, Ohio be and is hereby directed to submit the issue of the renewal tax levy to the electors of Morgan County at the general election to be held on November 3, 2009, said date being the first Tuesday after the first Monday in November.

BE IT RESOLVED, that the Clerk of this Board be and is hereby directed to immediately certify a copy of this Resolution to the Board of Elections of Morgan County, Ohio prior to the date of August 20, 2009.

09-391 Motion by Mr. Mike Reed and seconded by Mr. Don Reynolds to approve the following:

**DECLARING THE AMOUNT OF TAXES THAT MAY BE RAISED BY LEVY AT THE
MAXIMUM RATE AUTHORIZED BY LAW WITHOUT A VOTE OF ELECTORS TO BE**

INSUFFICIENT AND DECLARING THE NECESSITY TO A LEVY IN EXCESS OF SUCH RATE.

Be it resolved by the Morgan County Board of Commissioners, Morgan County, Ohio all members elected thereto concurring:

SECTION I. That the amount of taxes that may be raised by the levy of taxes at the minimum rate authorized by O.R.C. 5705.19 on the taxable property in said County will be insufficient to provide adequate amount of necessary requirements of said County, and it is necessary for the purpose of providing additional funds for an Operating Levy for the General Fund for a period of five years at a rate in excess of the maximum rate authorized by O.R.C. 5705.19.

SECTION II. That it will be necessary to pass the levy for taxes for tax years 2009, 2010, 2011, 2012 and 2013, being a additional tax of 1.00 mills on each dollar of tax valuation for five (5) years (which amounts to ten (10) cents for each One Hundred Dollars (\$100 of valuation), of the taxable property within Morgan County in excess of the rate authorized by O.R.C. 5705.19.

SECTION III. Be it further resolved that said levy be placed upon the tax list of the current year after the February settlement next preceding the election, if a majority of electors voting thereon vote in favor thereof.

SECTION IV. That the clerk be and is hereby directed to certify a copy of this Resolution to the Morgan County Board of Elections in order that the said board of Elections may make the necessary arrangements of submission of such questions to the electors of Morgan County at the General Election on November 3, 2009.
