The Board of the Morgan County Commissioners met in their offices on Monday, September 28, 2009 with the following members present:

The meeting was called to order at 8:30 am with the pledge of allegiance to the flag. The minutes of the September 21, 2009 meeting were read and approved.

The Morgan County Commissioners would like to acknowledge the Clerk of Courts and Title Office are closing on Fridays to help save the County General Fund expenditures.

The Commissioners also wanted to assure the public and especially Morgan County Transit users that Transit is not affected by the shortages in the General Fund. Transit is a Grant Funded Program of The Ohio Department of Transportation. They also have contracts with agencies within the County for other sources of revenue.

Gary Woodward, Auditor, informed Commissioners the Courthouse Maintenance line item does not have enough appropriations to pay the electric bill. Mr. Woodward discussed the Board of Elections and Transit's budgetary shortfall. Commissioner Reed stated Transit had received about \$36,000 in revenue with-in the last week.

Becky Thompson, Dog Warden, reported traveling 223.6 miles responding to dog calls. Mrs. Thompson stated eight dogs were picked up, S.P.O.T. took four dogs, and one dog was euthanized.

Kim Reed and Tina Work, Workforce Development Center, discussed child care and OJT contracts with ABC Manufacturing.

Vicki Quesinberry, Director, Job and Family Services, submitted a supply request for a sign for Workforce Development Center from Sign Pro in the amount of \$367.09.

Bailey Wilson and Louise Pennock, Board of Elections, discussed not having enough funds to operate. Mrs. Pennock stated their office never had the number of employees it's needed nor the amount of funding it's needed. Mrs. Pennock and Mr. Wilson stated the Board appreciates all the help the Commissioners give but want them to understand their position. Mr. Wilson stated they are frugal with the funds that are provided to them.

Betty Wells discussed dogs the County's Dog Warden picked up.

Shannon Wells, Morgan County Commissioners' Development Office, discussed Transit's budget. Commissioner Cain signed a purchase order for a new Transit vehicle to be funded 100% by stimulus money. Mrs. Wells informed Commissioners cost estimates for the Door/Concrete slab project for the Senior Citizen's Center are due Tuesday, October 13<sup>th</sup>, 11am. Commissioners were updated on the Septic Program. Mrs. Wells stated she will be attending the Tourism meeting after work on Wednesday.
