The Board of the Morgan County Commissioners met in their offices on Monday, July 19, 2010 with the following members present:

The meeting was called to order at 8:30 am with the pledge of allegiance to the flag.  
The minutes of the July 12, 2010 meeting were read and approved.

Becky Thompson, Dog Warden, reported traveling 195.4 miles responding to dog calls. Mrs. Thompson stated 8 dogs were impounded, 6 dogs were euthanized, and 1 dog was redeemed.

Ancil King Jr., Deputy Dog Warden, reported traveling 20.6 miles and 4.5 hours assisting the Dog Warden.

Marilyn Horner, Representative for the Burr Oak Regional Water District, submitted a letter from Wendy Aichele, Administrative Assistant, Burr Oak Regional Water District, informing the Commissioners Marilyn's term expires October 31, 2010. The Commissioners need to appoint a Commissioner or their representative to serve on the Board for a three year term beginning November 1<sup>st</sup>, 2010 and ending on October 31<sup>st</sup>, 2013.

Commissioners approved an application from Dean Wright, to bore under County Road 62, located in Bristol Township, Section No. 31, Morgan County, Ohio, for a 1 inch diameter gas line. The Construction of this project will begin on or about August 6, 2010 and will be completed by September 30, 2010.

Commissioners reviewed and approved the Continuity of Operations (COOP) and Continuity of Government (COG) plan as submitted by Terry Robison, Director, EMA/OHS.

Pam Montgomery, OSU Extension, updated Commissioners on Agriculture and Natural Resource, 4-H and Family and Consumer Science: the 10<sup>th</sup> Annual Ag & Livestock Field Day is scheduled for August 9<sup>th</sup> at Bruce Dozer's Farm; 4-H Camp will be held July 26<sup>th</sup>-30<sup>th</sup> (a total of 72 will be attending); Cloverbud Day Camp is July 21<sup>st</sup> (30 Cloverbuds will participate with 8 older youth in-training); Project judging was held July 13<sup>th</sup> for all non-livestock and July 15<sup>th</sup> for clothing projects (a total of 250 4-H members attended); Make-up judging is scheduled for August 3<sup>rd</sup> - members who missed judging can call to schedule an appointment or they can ask their advisor to judge their projects; Skilathon kits will be set up in the Community Room in the Riecker Building, August 12<sup>th</sup>, from 2-8pm, for members to practice; Dining wit Diabetes dates set for 2010 are as follows: September 30, October 7<sup>th</sup> and October 14<sup>th</sup>, from 6:30-8:30pm at the Presbyterian Church on Liberty (individuals can contact the Extension Office 740.962.4854 to get their name on the list for the program); Helping Children Cope with Divorce is scheduled for Tuesday, August 31<sup>st</sup> (individuals can contact the Extension Office to register). Elaine Lindimore, Family Nutrition

Program, presented the following topics: Morgan County United Ministries Food Safety and Power Outages- which covers overall food safety practices with a focus on power outage and how long it is safe to keep food in your refrigerator or freezer; Programs for Department of Job and Family Services and The Kids Shop hands on Basic Cake Decorating which focuses on the tremendous amount of food dollars you can save by decorating your own special occasion cakes; Women Infant and Children program- the main focus was Healthy Eating for Kids which addresses w\the parent’s role verses the child’s role at meal time; Upcoming programs for Women Infant and Children for pregnant women, Department of Job and Family Services and Morgan County united Ministries (Food pantry) will focus on Food for Good Nutrition. The next Extension Advisory Committee will be held on October 11<sup>th</sup>, from 7-9pm. Mrs. Montgomery told the Commissioners many positive comments about the condition of the Commons and thanked them for their maintenance of the Commons for the local farmers.
