# MORGAN COUNTY COMMISSIONERS RIECKER BUILDING

The Board of the Morgan County Commissioners met in their offices on Monday, October 25, 2010 with the following members present:

Mike Reed, President Don Reynolds, Vice-President Dean Cain, Member

The meeting was called to order at 8:30 am with the pledge of allegiance to the flag. The minutes of the October 18, 2010 meeting were read and approved.

**10-406** Motion by Mr. Mike Reed and seconded by Mr. Don Reynolds to approve the minutes from October 18, 2010.

Larry Carrel and George Strelecki requested the Commissioners investigate and view the lack of maintenance of County Road 11 (aka- East Hooppole Ridge Rd NE) by the County Engineer. It is their belief and the beliefs of the residents and neighbors that using 38 tons of drop patching material for approximately 3/4 mile is not being financially responsible to the county. A major concern is the safety of the school buses on the steep hill as the guardrail was removed and never replaced. A previous school bus accident happened on this hill and the road was not in as much disrepair. It was stated this road has been an oversight and severely neglected for over 25 years and repeated requests have been made of the Engineer to address the issues. Signatures of several residents and neighbors of Morgan County Road 11 were submitted. Commissioners invited Stevan Hook, Engineer, to the Commissioners Office to address the concerns. Mr. Hook remarked he applied for money to repair County Road 11 and did not receive the funding. Mr. Hook stated he would not argue with the gentlemen that County Road 11 is in terrible condition, however; there is not sufficient funding to pave all the roads in the county that need it. The roads that are the worse and have the most traffic are fixed first. In addition, Engineer Hook also explained the point system for Ohio Public Works- Issue I money.

Becky Thompson, Dog Warden, reported traveling 159.7 miles responding to dog calls. Mrs. Thompson stated 1 dog was impounded and 2 dogs were euthanized.

Commissioners approved an application submitted by Charlie L. McCabe Jr., to bore under County Road 51, located in Deerfield Township, Section No. 17, Morgan County, Ohio to be for a ¾ inch water line. The Construction of this project will begin on or about October 27, 2010; and will be completed by October 28, 2010.

Vicki Quesinberry, Director, Job and Family Services, submitted meeting request for Jan Snouffer and Jody Murray to Hocking County for training on "Victims & Corrections: Issues, Services, & Trends" held on November 10<sup>th</sup>; Jan Snouffer and Jody Murray to Malta for training on "Suicide Prevention" on November 16<sup>th</sup>.

Shannon Wells, Morgan County Commissioners' Development Office, informed Commissioners Transit terminated 3 employees. Tuesday, October 26<sup>th</sup>, the Development Office will be closed for CHIP grant

training. It was mentioned that no payment has been received from ABC Manufacturing for the month of October. Mrs. Wells opened the bids received for the maintenance for Transit vehicles from: Quick 60 in the amount of \$30 per hour and \$23.55 for a basic oil change and Parkway in the amount of \$50 per hour and \$28.00 for a basic oil change.
