

**MORGAN COUNTY COMMISSIONERS
RIECKER BUILDING**

The Board of the Morgan County Commissioners met in their offices on Monday, November 22, 2010 with the following members present:

The meeting was called to order at 8:30 am with the pledge of allegiance to the flag. The minutes of the November 15, 2010 meeting were read and approved.

10-468 Motion by Mr. Mike Reed and seconded by Mr. Don Reynolds to approve the minutes from November 15, 2010.

Commissioners approved an application submitted by American Electric Power, to span over County Road 3, located in Malta Township, Section No. 24, Morgan County, Ohio to be for an electric line. The Construction of this project will begin on or about January, February or March 2011; and will be completed by summer of 2011.

Becky Thompson, Dog Warden, reported traveling 105 miles responding to dog calls. Mrs. Thompson stated 2 dogs were impounded and 3 dogs were taken by SPOT.

Ancil King Jr., Deputy Dog Warden, reported traveling 100.2 miles and 9.5 hours assisting the Dog Warden. Ancil stated one dog was redeemed.

Heidi Burns, Job and Family Services, submitted a request for procurement for display stand for touch screen kiosk with top and bottom graphic header panels from Marketeers in the amount of \$484.

Stevan Hook, Engineer, discussed rehabilitating the San Toy Covered Bridge.

Judge Favreau, Common Pleas, discussed budgetary concerns and the Ombudsman Program. Judge Favreau received a letter submitted by Washington-Morgan Community Action informing: as of December 31, 2010 they will no longer have the resources to continue to provide the services. The Judge stated the importance of this program and the significant dollars that Morgan County has saved over the decade since the program has been in existence.

Vicki Quesinberry, Director, Job and Family Services, met with Commissioners to discuss the Ombudsman Program.

Will Eppley held a conversation with Commissioners concerning junk cars in the Rosefarm area.

Shannon Wells, Morgan County Commissioners' Development Office, inquired on ABC Manufacturing paying interest only for the next three months: December, January and February. This will consist of them using 10 of the 12 allowed for interest only payments. Commissioners agree to allow ABC Manufacturing to pay interest only for the next three months. Mrs. Wells stated ABC Manufacturing's note is going to be restructured; nonetheless, there will still be a balloon payment at the end of the note. Shannon informed the Commissioners, Center Township canceled their Formula 2009-Community Development Block Grant handicap ramp project. Commissioners agree to transfer the money for Center Township to the Senior Citizen's Re-Roof Project. A discussion was held concerning the rehabilitations for the Transit facility; the State is now paying for the entire project. Shannon requested the bids for the rehabilitation for the Transit facility be un-tabled and all bids be rejected.

Dawn Rauch, Washington-Morgan Community Action, Matthew Bennett and colleague from Dovetail Solar and Wind, discussed performing a study to install solar panels on the Riecker Building. Washington-Morgan Community Action is paying for the study. Mr. Bennett informed the Commissioners of the incentives and inquired on additional buildings the county owns that may benefit from installing solar panels. The Commissioners stated the Courthouse and the Learning Center would be an option.

Larry Albert inquired on owner release forms and why the county's Dog Warden is going after owner release dogs instead of one of the Humane Societies. Commissioners commented that the Dog Warden is saving an abandoned dog by picking up owner releases. Larry stated he is not a member of SPOT or the Morgan County SPCA. Larry stated he is just a dog lover that wants what is best for dogs. Commissioners agreed they want what is best for Morgan County dogs as well.
