Jeff Babcock, Network Administrator

Worked with Randy Robillard's IT firm to figure out why he could not log in remotely to the Auditor's server. There were two issues – either of which would have kept him from ever connecting to the Auditor's server – that turned out to be firewall configurations on both ends. Changes were made and Randy's IT people confirmed that he was able to access the server.

Cleaned the NOC, starting inventory of phone equipment/spare parts. There are about 10 spare DSS-48 units (the extra button consoles that sit beside the phone) – 8 of which are new. However, of the spare phones, there are no new units. Will start testing the spare units to see which are good and which need replaced.

Started server prep work for server upgrade in the Engineer's office. Bruce Harris Associates (BHA) made the suggestion that the Engineer upgrade his server to alleviate the slowness that had been plaguing his GIS officer. The parts arrived from Computer Plus and we started trying to back up the servers data directory. Unfortunately, several files will not copy. We are in touch with BHA to see what, if anything, needs to be done.

Mr. Babcock is concerned about hours report. He set up his spreadsheet to track time that he worked for a particular office solely. Mr. Babcock thinks they are taking this to mean that is all that I am doing for them. He doesn't know how to track the work he does that benefits the Riecker building as a whole.

"Several offices are concerned about how I am prioritizing my workload. They feel that I am ignoring them. Some suggestions were offered as to how we can fix this mis-perception. One of the things that I will start doing is tracking my hours in 15 minute intervals throughout the day and state which office I was with for each interval and the work I did for each office."
