Whereas, pursuant to this rule, the Board of County Commissioners needs to adopt a verification procedure and a plan to recoup all or part of the cost of counsel for persons who meet certain income guidelines.

It is hereby resolved that:

The Courts of this county shall make the appointment of counsel, either private assigned counsel or the County Public Defender, in accordance with the rules established by the Ohio Public Defender Commission and the State Public Defender to enable this county to receive reimbursement from the state for a part of the indigent defense costs.

Payments shall be made pursuant to the Morgan County Indigent Defense Fee/Cost Recoupment Policy, a copy of which is hereby attached to this resolution.

This resolution shall be effective for all cases with an appointment date of June 7, 2004 or later.

RESOLUTION # 04-227

WHEREAS, it is determination of the County Commissioners that the amount of tax within the ten mill limitation of levies on the current tax duplicate will be insufficient to provide the necessary requirements of the county's contribution to the joint county mental health and alcohol, drug addiction service district of which the county is a part; therefore,

BE IT RESOLVED, that in accordance with the provisions of R.C. 5705.221 the Board of County Commissioners of Morgan County hereby declares it necessary to levy a tax in excess of such limitation for the **OPERATION OF MENTAL HEALTH AND RECOVERY PROGRAMS**, and the acquisition, construction, renovation, financing, maintenance and operation of mental health and recovery facilities, and to submit to the electors the renewal of such existing tax heretofore levied in this county.

BE IT FURTHER RESOLVED, that such renewal levy shall be at a rate not exceeding eight tenths (8/10) mill for each one dollar of tax valuation, which amounts to eight (8) cents for each one hundred dollars of tax valuation for a period of ten(10) years commencing with tax year 2004.

BE IT FURTHER RESOLVED, that the Board of Elections of Morgan County, Ohio, Be and is hereby directed to submit the issue of such renewal tax levy to the electors of Morgan County, Ohio, at the election to be held on November 2, 2004, said date being the first Tuesday after the first Monday in November, 2004.

BE IT RESOLVED, that the Clerk of this Board be and is hereby directed to immediately certify a copy of this Resolution to the Board of Elections of Morgan County, Ohio, prior to the date of August 19, 2004.
