- We are in the middle of the six-week series of programs at Six County Incorporated, on the powerful nutrients in fruits and vegetables, which we need to increase in our diets. With this group we also compare the carbohydrates in the food as a few participants have diabetes.
- At the Mary Hammond Workshop the emphasis is on low fat protein options and we have added a weekly cooking component this. If not for the support of the workshop supplying the food recipes this would not be possible due to the budget cuts to SNAP-Ed. The participants look forward to helping prepare healthy recipes as well as sampling. This month we have made homemade chicken noodle soup and compared the fat a sodium content against canned chicken noodle soup, we also prepared tuna melts and compared the fat and protein content against other protein options such as a hot dog, cheeseburger or pork chop.
- A series of three programs are scheduled at the library for January 27th. February 3rd and 10th the time is 1:00pm to 2:00pm. The programs will focus on eating healthy while trying to lose weight. Anyone interested in signing up for the program you can call the extension office to register by January 27th.

WHEREAS, the occurrences of referrals of abuse, neglect, and exploitation of both older adults and children in Morgan County are dramatically increasing and the departments mandated to investigate and serve victims of abuse and neglect are critically under-funded, and unable to assure the safety and protection of our most vulnerable residents.

WHEREAS, the purpose of the levy is to provide services for abused, neglected and exploited older adult residents (aged 60 and older) and abused, neglected and exploited children including but not limited to: investigation, prosecution, court preparation, case management, protective placement, prevention education and service coordination.

WHEREAS, the amount of taxes which may be raised within the ten mill limitation will be insufficient to provide an adequate amount for the necessary requirements of said Morgan County, Ohio and the tax levy is necessary to supplement the protective services fund for the purposes of providing said social services, and

WHEREAS, the Board of Commissioners must obtain a Certificate of Estimated Property Tax Revenue from the Morgan County Auditor prior to certifying this levy to the Morgan County Board of Elections.

Commissioner Reed makes a motion of intent to place a new levy on the May 5, 2014 ballot for adult protective services/child protective services. The levy shall be for .5 mill (half) a mil or five cents per \$100 of real property evaluation. The levy shall be for five years commencing in tax year 2014 first collected in 2015. The purpose of the new levy is to provide protective services for abused, neglected or exploited older adult residents (aged 60 and older) and children including but not limited to investigation, prosecution, protective placement, and education. Seconded by Mr. Shriver Pursuant to revised code 5705.24
