JFS reported that their fax machines were not working. After various attempts to trace the problem, the JFS director contacted Advanced Business Communications (ABC) to assist. Two things were discovered; first, the spare single-line card in the Network Operations Center (NOC) was bad and, second, the ring generator unit was what was causing the problem with their fax machines (we did not have a spare of this part on the shelf).

ABC mentioned that they recently pulled a phone switch out of Miba that is identical to the one that we have at the Sheriff's office. I have determined that we either need a new processor card or a new back-plane for the switch module. ABC confirmed that the processor card I have on hand will not work with the existing database in the Sheriff's phone switch. ABC has these parts on hand and have the tools to determine which is bad in the Sheriff's phone switch. Can we call them to replace the bad parts?

Upgraded Bo's ArcGIS to version 10.3.1, the newest version. He reports that it is running better than the old version, but the original problem of having to reboot after saving edits still persists. He is going to discuss this with Bruce Harris Associates (Engineer's GIS consultants) during their upcoming visit.

DJH advises that the parts we ordered last week will be ready on Wednesday; except the fiber optic cables, which are on backorder.
