The IT Director discussed the billing of non-general fund hours with the Auditor's office to confirm that the correct offices are being billed for IT support. The Auditor's office confirmed that the offices that were billed at the beginning of 2016 was correct.

New computers were received from the DJH Computers for the Treasurer's office and software configuration is underway.

Antivirus software installations continue with about 60 computers protected. This project is about 85% complete.

The IT Director was able to get the telephone switch's configuration software to work on a non-Windows PC. This will allow two more Windows XP machines to be removed from the county inventory and allow the phone switches to be hooked back up to the main network. Prior to this, any PCs that required Windows XP to run proprietary software was put on a separate "maintenance network" along with the devices that they controlled. This was a last-ditch effort to keep the Windows XP machines secure while retaining their functionality.

The IT Director will call Advanced Heating and Cooling and schedule repairs on the 75-ton Trane AC unit on top of the Riecker Building (RTU-1). RTU-1 has a small freon leak. Advanced Heating and Cooling will replace the bad coil assembly with a new one.
