The program will help with housing improvements for low-income citizens up to 12 home repairs and 1 Habitat for Humanity projects will be completed. Morgan County will include \$22,000 on the Habitat Program.

-Engineers RFQ's will be opened and reviewed by the Village of Malta and brought to the commissioners for review. This is regarding the widening project is South Malta. The commissioners wanted to be sure that the River Queen's parking is preserved and not affected by this project. The widening project it at all according to Mrs. Wells.

On 22 December 2017, the IT Director met with representatives from Verizon Government Services to discuss the County's wireless accounts. The County currently has several different plans in place that were initiated by individual offices all using the same tax ID. This has created a situation where no new devices or accounts can be added for other offices. The goal will be to create one account for Morgan County Government and move all other accounts under that account. CTS Software also joined the meeting via phone to discuss the purchase of mobile devices for Morgan County Public Transit and the timetable for deployment.

On 27 December 2017, the IT Director attended the Zanesville - Muskingum Chamber of Commerce Safety Council meeting in Zanesville. The topic of discussion was noise and noise reduction with a focus on OSHA regulation governing noise in the workplace.

The IT office equipment inventory was sent to the County Auditor's office on 28 December 2017.

The IT Director finished loading the last of the electronic copies of the Commissioners' Meeting Minutes onto the County's website and updated the web pages.

There is a potential issue with the e-mail addresses in use by the Morgan County Health Department (MCHD). Some addresses are receiving a high rate of spam e-mail and the cause is unknown. The IT Director will start to move the MCHD e-mail addresses to the County's government domain.
