- -The commissioners and Mrs. Wells have secured funding for the Roundabout Project. However, Mrs. Wells was told by Mr. Allen Craig the funds are not able to be released until the project begins in June 2018. She is currently looking into Roundabout loan options from Peoples Band and Citizen's Bank. The project will need a loan for \$400,000.00 coming from the Revolving Loan Fund (RLF) and \$119,000.00 coming from the Critical Infrostructure Grant, for a loan totaling \$519,000.00. Mrs. Wells has drafted emails explaining the situation to both banks. Although she did not receive a response from Citizen's Bank, she did receive and offer from People's Bank with an interest rate of three percent (3%). If it becomes necessary to take out a loan for the project, the commissioners would like District 10 to pay the interest that will collect on the loan since it wasn't explained that funds would need to be paid before the project begins. Commissioners are not happy and want ODOT to make it right

The IT Director has started cleaning the database and ensuring that all devices in the database are up-to-date and that full scans are being run on a weekly basis.

The FTR Reporter software on the court recorder PCs at Common Pleas and Juvenile and Probate Courts failed this past week. It was determined that an update for Windows 10 to secure PCs against the recent Meltdown and Spectre vulnerabilities caused the FTR Reporter software to stop working. Removing the update resolved the issues with the FTR Reporter software.
