"Stepping Up to Reduce the Number of People with Mental Illnesses in Jails

Whereas, counties routinely provide treatment services to the estimated 2 million people with serious mental illnesses booked into jail each year;

Whereas, prevalence rates of serious mental illnesses in jails are three to six times higher than for the general public: Whereas., almost three-quarters of adults with serious mental illnesses in jails have no co-occurring substance use disorders;

Whereas, adults with mental illnesses tend to stay longer in jail and, upon release are at a higher risk of recidivism than people without these disorders;

Whereas, without the appropriate treatment and services, people with mental illnesses continue to cycle through the criminal justice system, often resulting in tragic outcomes for those individuals and their families;

Whereas, Morgan County and all counties take pride in their responsibility to protect and enhance the health, welfare, and safety of its residents in efficient and cost-effective ways;

Whereas, through Stepping Up, the National Association of Counties, the Council of State Governments Justice Center, and the American Psychiatric Association Foundation are encouraging public, private, and nonprofit partners to reduce the number of people with mental illnesses in jail.

Now Therefore, Be It Resolved, that we the Morgan County Commissioners, do hereby sign on the Call to Action to reduce the number of people with mental illnesses in our county jail, commit to sharing lessons learned with our other counties in our State and across the Country to support a national imitative and encourage all County officials, employees, and residents to participate in Stepping Up to:

Convene or draw on a diverse team of leaders and decision makers from multiple agencies committed to safety reducing the number of people with mental illnesses in jails;

Collect and review prevalence numbers assess individuals' needs to better identify adults entering jails with mental illnesses and their recidivism risk, and use that baseline information to guide decision making at the system, program and case levels;

Examine treatment and service capacity to determine with programs and services are available in the County for people with mental illnesses and co-occurring substance use disorders and identify state and local policy and funding barriers to minimizing contact with the justice system and providing treatment and supports in the community;

Develop a plan with measureable outcomes that draws on the jail assessment and prevalence data and the examination of available treatment and service capacity, while considering identified barriers; Implement research based approaches that advance the plan; and

Create a process to track progress using data and information systems, and to report on success.

On 24 January 2018, the IT Director attended the ZM Chamber of Commerce Safety Council meeting in Zanesville, Ohio. The topic of discussion was aerial drone uses and the regulations governing them. The presentation was given by the Bureau of Workers' Compensation (BWC). The BWC demonstrated the software used with drones and discussed their use of drones in investigations.

An online tax-exemption form was provided to Amazon.com. As a local government entity, the County Commissioners' Office is entitled to tax-exempt status. However, Amazon.com had been adding tax to some (though not all) of the County's orders. Completion of this form will prevent unnecessary work for the Auditor's Office when paying bills for Amazon.com orders.

The IT Director ordered computers for each of the County Commissioners. Computers will be configured with their e-mail and scheduling software.

The IT Director built new computers for his office by recycling parts from County Court's old computers.

The Commissioners asked the IT Director to move forward on canceling the County's old Internet Service Provider contract with Horizon.
