Morgan County Interconnection Project Partners

Participation Partners: Morgan County Board of Commissioners, Development Office, Morgan County Engineer, Village of Chesterhill, Village of Malta, Village of Stockport, Morgan/Meigsville Rural Water District, Tri-County Rural Water District, Ohio RCAP and IBI Group

- The Commissioners received funding from the Local Government Innovation Fund in 2016 to assist water
 utilities in developing a plan for providing an un interrupted supply of safe drinking water to Morgan
 County residents. The project creates a model for sharing services related to providing emergency drinking
 water supplies.
- Access to public in Morgan County is primarily supplied by five participating partners in the study:
 1)Village of Chesterhill, 2)Village of Malta, 3) Village of Stockport 4)Morgan/Meigsville Water District
 5)Tri-County Rural Water buys from Malta; The other three utilities have wells.

- All utilities' source waters are classified by Ohio EPA has being "highly" susceptible to contamination. Over 20 years ago, the Village of Malta experienced a water contamination event that required the development of a new source.
- Chesterhill and Stockport are interconnected; the Village of Malta and Tri-County have no back-up interconnection. Currently Malta sells water to Morgan/Meigsville and the Village of McConnelsville.
- The study will analyze the best routes, lowest cost options of connecting Tri-County, Morgan/Meigsville, Malta, Stockport and Chesterhill along with identifying options for ownership, financing and maintenance.

Following in a summary of the utilities' demographics. Data sources include the Census and ACS. Estimates for Morgan/Meigsville and Tri-County Districts were estimated from corresponding County data and data from respective utility.

- IBI completed a feasability study using Bentley Water CAD for the hydraulic modeling. The model phased in each system losing their water supply, first Chesterhill, then Chesterhill and Stockport, Malta then Tri-County. Note if Malta loses their supply, so do Morgan/Meigsville and McConnelsville. Total project cost to have all utilities connected was estimated at \$2,226,400.00. The study then estimated the additional OMR costs associated with operating larger pumps, valves and other related appurtenances that would result in an increase in the operating budget. Total additional OMR was estimated to be around \$52,460.00 annually.
- Project Partners then presented the interconnection project to the Small Community Environmental Infrastructure (SCEIG) Finance Committee. This Committee is made up of representatives from State and Federal agencies that provide grants/loans to construct water/sewer infrastructure. The Committee meets bio-monthly to provide advice on eligibility for financing through their programs. None of the potential funders thought this project would be eligible for grants or loan subsidies, i.e. since there is currently not a problem, it wouldn't be an eligible, very competitive project presented as an interconnection project. Rather they advised to segment or phase the project scope and define as a water line extension project to serve new customers, not an interconnection one. This is problematic as some phases would not serve new customers.

Note that the number of connections for M/M differs from Feasibility Study, i.e. they are adding new customers.

- The Project Partners then reviewed funding the entire project with a market rate loan (3.28%) from OWDA for 30 years. The resulting annual debt service payment plus the increased OMR equaled around \$208,653.00. That divided by the estimated number of connections (3,667) would result in an increased monthly user fee of around \$4.74 per connection. This was deemed unaffordable and not feasible to implement.
- Next the Partners requested IBI to segment or phase the project based on the SCEIG's recommendations. See the phases below. This also includes estimates of financing through a market rate OWDA loan and the number of connections with each phase. Note that Chesterhill does not have the water capacity to serve Tri-County, so only Chesterhill's connections are included. These Phases were also considered unaffordable with the exception of the Chesterhill/Tri-County connection.

- Finally, the Partners reviewed the potential to get grant funds for some of the phases: 1) Interconnect
 between Chesterhill and Tri-County due to lower cost, and 2) Interconnection between Morgan/Meigsville
 due to impacting a larger customer base and being able to pick up new users.
- If Chesterhill qualifies for CDBG funds with the new survey, this project might be eligible for the county's Allocation Program. There would be negligible additional OMR expenses.
- To make the project affordable for the M/M and Chesterhill Connection, grant subsidy (ARC,CDBG, OWCA) would need to be around 60% along with 0% and other low interest loans (OPWC, OWDA). Would need to include interconnection with Tri-County to get more points. The total project costs would be around \$1,238,000.00 (or \$1,038,000.00 if installed without booster station) and estimated additional monthly user charge for M/M would be around \$2.30 to \$0.71.
