-Plan for park totaling 5,720 acres in Morgan County. There will be a state park and wildlife area. Camp grounds will remain (primitive camping.) Miners Memorial is donated and the state will operate it. The wildlife portion of ODNR will pay PILT, 35% of taxable value. Annual payment. 4,843ares roughly in the wildlife area, PILT eligible. AEP will retain oil/gas rights. Commissioners need to get with Auditor to find taxable value of those rights. Sold for \$1935.00 per acre ODNR did get the coal rights. This will be marketed as a state park which is believed to be better from usership point of view. Camping registration will be done the same as at other state parks. Boat fuel tax will be used to invest in this particular park-to be named Jesse Owens State Park and Wildlife Area. No PILT payment on the additional 825 acres of state/park area. Commitment from ODNR to drive people to Morgan County from a marketing stand point.

Power outages would begin within 10 minutes of the notification. Unsure as to what buildings would lose power, the IT Director and Facilities Maintenance Officers shut down the elevators in the Riecker Building and Courthouse and were on standby to shut down HVAC and computer equipment. As it turns out, power was not turned off to any County buildings during the outage.

One of the Riecker Building's air conditioning units (RTU-2) failed on a warm day this past week. This was due to a faulty evaporator valve that needs to be replaced. Unfortunately, due to the excessively cold days this past winter, a time was never scheduled to replace the valve. Advanced Heating and Cooling will contact the County when a technician is available to do the work.

The Common Pleas Court and Sheriff's office each received two new Xerox printers/copiers this past week. A representative from iTech WV was available to ensure everything was set up and working correctly.
