On the evening of 2 July 2018, McConnelsville lost power for several hours. At opening of business on 3 July, the phones were offline in the Riecker Building. The phone system was reloaded from backup and returned to operational status. The Internet was down in the Riecker Building as well. The perimeter firewall was locked up and had to be restarted to restore Internet connectivity. Finally, a network switch failed at the Courthouse and had to be replaced.

On 3 July 2018, one phase of power was dropped to the Riecker Building causing all three air conditioning and ventilation systems to go offline. Once the breakers inside the units were reset, they were powered back up with no problems.

The IT Director finished moving the IT Office into the Network Operations Center (NOC) room of the Riecker Building.
