-The IT Director discussed Agile Networks' Internet installation with Belmont County Commissioner Josh Meyer. Belmont County is extremely happy with the service provided by Agile Networks adding that they were easy to work with and very accommodating. The customers of Agile Networks also seem to be happy with the broadband service provided. Agile Networks started talks with Belmont County in early 2017 and they started installing equipment in October of 2017. Agile Networks approached the County to use any vertical assets owned by the County as well as fiber infrastructure. It should be noted that Belmont County had significant fiber infrastructure in place prior to working with Agile Networks, but Agile was willing to invest in fiber for them. Finally, Commissioner Meyer noted that having Agile Networks providing broadband to rural locations in Belmont County seemed to motivate the existing broadband carriers into going the extra mile for their customers and would-be customers. An example from Commissioner Meyer was that one carrier became increasingly willing to run additional cable down rural roads to connect more people to broadband Internet.

The Commissioners asked that the IT Director follow up with Agile Networks regarding what exactly is needed from the County as well as the EMA Director regarding the vertical assets in Morgan County.

It appears that Avast Free for Business is going to a pay only service. The IT Director has been researching alternatives to Avast, both free and paid. Research and testing is ongoing.

The IT Director received a sales call from Vertical (the company that bought Vodavi, manufacturer of the County's phone PBX system). Vertical has a PBX system for called the Summit 800 that will work with the County's existing Vodavi digital phones, new Vertical digital phones, and several makers of voice over IP (VOIP) phones. Vertical will send additional information on the Summit 800 PBX.
