Minutes for October 22, 2018

The meeting was called to order by Stevan Hook, executive committee meeting. Those county sub-committee members present are:

<u>The 1st order of business</u> was to assign the County's priority points to the four (4) submitted projects. Stevan Hook explained that the purpose of the meeting is to assign County priority points to each of the projects (maximum of 4) submitted by the Morgan County applicants. He then presented the county's "4 projects" and discussed how the points might be distributed.

The projects are to be assigned priority points as follows:1st-75 points, 2nd-65 points, 3rd-55 points, 4th-45 points. <u>Project Representatives</u>

John Thompson presented and discussed the McConnelsville Village Water Line Installation Project with the subcommittee.

Ken Peters presented and discussed the Chesterhill Sewer Project.

Stevan Hook then presented the county's "Township and County Co-operative Road Paving Projects" and then discussed how the County Sub-Committee points might be distributed.

- Morgan County Paving Project #1-(Includes Morgan County Roads #9 (Sharps Ridge Road), #49 (Snyder Road) #75 (N) (Rosefarm Road.)
- Morgan County Co-operative Paving Project #2-Includes a portion of Center Twp. Road #941 (Creek Road.,) Malta Village (Various Streets), McConnelsville (8th Street and Oakwood Drive.)
