#### Jeff Babcock, IT Administrator

Commissioner Mike Reed noted that the County's monthly bill from CenturyLink for the T1 PRI in the Riecker Building was \$240; \$230 for PRI channel B and \$10 for PRI channel D. He could not find a bill for any other channels. Commissioner Reed will follow up at CenturyLink and the IT Director will follow up with the Auditor's office regarding bills paid to CenturyLink.

The Dog Warden's iPad has a failing SIM card. A new SIM card was sent by Verizon, but has not been received yet. The IT Director will follow up with Verizon on the SIM cards location.

The IT Director started asking various offices throughout the County about applications for telephone systems that fall in the range of public health or emergency notifications. Grant money is available to government entities for improvements to these processes; including the purchase of telephone equipment.

The IT Director reported that the spreadsheet in the request for information from Agile Networks is almost complete. There is only a few more dollar values that need to be obtained from the Auditor's office. The other two agreement documents were sent to the Prosecutor's office for review, but have not been approved yet.
