- On 28 November 2018, the voicemail system for the County's phone system failed. The voicemail system also operated the Jobs and Family Services' (JFS) auto-attendant; answering calls to the main numbers and directing calls accordingly. Advanced Business Communications came to remove the call forwards that directed JFS main numbers to the failed auto-attendant. Advanced Business Communication also sent a quote to procure, install, and program a refurbished voicemail and auto-attendant. Due to its age, new voicemail systems are no longer available.

A hard drive failed in one of the computers in the Clerk of Courts office. The computer, which was a little over a year old, was returned to the vendor for repair. This is the second computer at the Courthouse that was purchased in late 2017 to suffer a hard drive failure. More attention will be devoted to data backups on these computers.

A new computer was delivered to the Morgan County Health Department (MCHD) for the Plumbing Inspector. This computer will eventually house a new database of plumbing inspections, so system and data backups will need to be implemented and performed frequently.

The Dog Warden reports for 2016 and 2017 were scanned and placed on the Dog Warden's webpage. An archive of the entire year's reports was also created and placed online for easier downloading.
