- Continuing to work on inventory of grant purchases *will be doing actual physical inventory across the County over next few months.*
- Working on purging old files, per advice from Monitoring visit.
- Continue working with townships on Public Assistance grants
- Completed and submitted EMPG (Emergency Management Performance Grant) Q5 reimbursement request in amount of \$9557.32. This is a 50% reimbursement grant so anticipating payment of \$4778.66.
- Applied for HMEP (Hazardous Materials Emergency Preparedness grant) for LEPC to fund tabletop exercise. Received approval for grant of \$6000. This is an 80% reimbursement grant so LEPC maximum exposure is \$1800. Preparing RFPs for contractors.
- Attended kickoff for Region 8 Homeland Security Knowledge Center database. This is an interoperative
 tool for emergency and everyday management of resources/personnel. Will be holding training for
 designated partner stakeholders within a couple of months. Will be available to all townships, villages, law
 enforcement, fire departments, Health, Engineer, JFS, etc. This also requires a lot of data collection and
 input for the initial startup.
- Investigated erroneous data from McConnelsville streamgage and reported outage to US Geological Survey (they maintain the gages) and also to US Army Corps of Engineers and National Weather Service Hydrologic office. The gage freezes up anytime we have ice on the river and gives totally erroneous readings. This was part of the issue with the ice jam flooding last year as the Corps was releasing a lot of

- water from Dillon and not seeing a rise on McConnelsville gage. The USGS data people will be addressing the issue.
- Working with Health Department on servicing BluMed trailer so it is in immediate deployable condition.
 Due to outside storage the battery will need replaced and the diesel generator/climate control system will need services.

Dear Director:

The Ohio Department of Agriculture (ODA) each year conducts an extensive trapping program across Ohio to detect growing populations of the invasive species *Lymantria dispar*, better known as the Gypsy Moth. This insect does its damage by defoliating the tree during its caterpillar life stage. A couple of years of defoliation and other environmental stresses can cause the trees to die. With over 300 species of trees and shrubs that can be affected, it is considered one of the most destructive insect pests threatening our forest and ornamental plants in Ohio. If left unchecked, Gypsy Moth infestations can grow quite rapidly. Therefore, it is vital to eliminate growing populations as soon as possible.

ODA has recently completed an analysis of Gypsy Moth populations throughout Ohio. Based on rising moth captures and/or egg mass counts within your area, we have concluded that a treatment is needed. ODA, in cooperation with the United States Department of Agriculture (USDA), Forest Service / Forest Health Protection / Gypsy Moth Slow the Spread Program will be conducting a Gypsy Moth Treatment Project during the months of May and June in your area. Aerial treatment(s) of forested areas infested with the Gypsy Moth pest may begin in early to mid-May with a larvacide treatment and in mid-June, with a mating disruption treatment.

The purpose of this letter is to inform your department that this program will take place and supply you with informational material so that your staff is well informed to answer any questions from the public.

Treatments will be made with the following:

- A single application of the biological insecticide *B.t.k.* (*Bacillus thuringiensis*, subspecies *kurstaki*, known under the commercial name **Foray 48B**, to the tree canopy. This application(s) will occur in early to mid-May while the pest is in its early caterpillar stages. When ingested by the Gypsy Moth, toxins form in the stomach causing the caterpillar to stop eating, resulting in its death.
- A single application of mating disruption product, **Splat Gypsy Moth Organic**. The product contains a synthetic Gypsy Moth pheromone, *disparlure*. This application will occur in early to mid-June at the beginning of the mating season. When applied to the tree canopy, the pheromone disrupts the communication between the male and female moths, preventing them from finding each other and mating. This treatment does not kill the Gypsy Moth but reduces the population in the area for next year.

Even though scientific research shows the products used are not considered harmful to humans, residents with concerns may want to remain indoors during the treatments, but there is no requirement to do so.


All treatments will be applied from an aircraft flown approximately 50 to 100 feet above the tree tops. The exact time and date of treatment applications in your area cannot be determined in advance. The timing of treatments is dependent on insect development and environmental conditions. We will attempt to contact your department by phone or e-mail prior to the start of treatments in your area.

-Troubleshooting continues on the refurbished voicemail system in the Riecker Building. The issue of date and time not being recorded with messages has been resolved. The only outstanding issue is the lack of visual notifications on the handsets when voicemails are received.

The failed single-line interface board on the Riecker Building's phone switch has been replaced and all phones and fax machines on that card have been restored to operation.

Research has begun on security information and event management (SIEM) software that would be suitable for the County's network. The uses of SIEM software is likely going to be required by the Secretary of State as part of its effort to secure the Board of Elections network infrastructure. There does not appear to be a single all-in-one solution. Two pieces of software that seem viable at this time are OSSEC (a host intrusion detection system) and LOGalyze (event log manager). Research and testing are ongoing.

On 23 January 2019, the IT Director and Commissioner Mike Reed attended the Zanesville – Muskingum County Safety Council in Zanesville. The topic of this Safety Council was medical marijuana and BWC claims, presented by Scott Sinclair of the Bureau of Workers Compensation.

Countywide replacement of antivirus software on computers has begun. The software that was being used, Avast Free for Business, changed their business model to a pay service. Avast will be removed from computers and Comodo Internet Security will be installed. Comodo is free and highly rated, but lacks the centralized management and notifications that a paid business antivirus suite would offer.
