- Public Hearing for 2019-scheduled February 26, 2019 at 10am.
- Transit-Fare restructure-sent concurrence letter to ODOT and need to go through a public hearing process. Applicants to consider for part-time driver will be interviewed soon.
- Chesterhill Sewer-IBI Group applying for Transportation Alternative Funds (TAP) and will use
 Neighborhood Revitalization (NR) as match. TAP funds be used for curb and sidewalks. Sewer \$2.9m,
 Streets \$1.9m, TAP \$500K, NR \$500K. \$5.8m total. Citizen participation meetings scheduled for March
 4th at 6pm, March 24th at 2pm and April1st at 6pm.
- McConnelsville Neighborhood Revitalization grant-need to schedule citizen participation meetings
- Bristol Waterline-Six low income homeowners being assisted with Residential Public Infrastructure Grant
 for assistance on TAP fees and line from tap to home. Approximately two dozen homes will receive water.
 Will be sending out specs and getting three quotes for contractors to install waterlines in the six homes.
- Malta 3rd street bid-Repair work still needing addressed by Shelly and Sands. Will wait until spring. Bond good for one year. Shelly responded by email to confirm work to be done. Drawing funds from ODOT Jobs & Commerce \$80,000 Only ably to draw \$79,356 until remaining \$5,000 spent to Shelly and Sands.
- Natureworks 2018 Shelter house project-waiting for signed agreement to return.

- Health Department Handicap Door Buttons-environmental review stage. Release of funds submitted to state last week. Will be able to get quotes for work soon.
- Recycling-Zero waste initiative. Rural Action to send waste report in a couple of weeks.
- Opera House-Progress meetings being held weekly.
- Roundabout-1st payment towards roundabout loan made of \$45,366.35. 2nd payment on loan made of \$99,340.97. Total repayment to date \$144,707.32. Requested documentation from ODOT for third payment \$55,634.45.
- Septics-will be getting quotes from Randy Myers NPDES system.
- Community Housing Improvement Program (CHIP) -pre-bid scheduled for Friday Housing Advisory Committee (HAC) meeting will be scheduled soon to plan for upcoming grant.

She met with Jason Baughman from Mideast Building, he was called in to provide information on the condition of the building. He said it was structurally sound. Commissioners asked Mrs. Wells to provide a written report to them for their records.

Jeff Babcock, IT Administrator

On Sunday, 24 Feb. 2019, the McConnelsville area experienced high winds that resulted in several power fluctuations. During this period of power fluctuations, a phone issue at the Sheriff's office that had been ongoing was cleared. The phone issue was that one of the Sheriff's office's four outside phone lines was in an out-of-service status. When the phone switch rebooted during the power fluctuations, the problem was resolved.

A long standing Internet issue was repaired at the Courthouse over the past week. Previously, the Internet at the Courthouse was working, but experiencing intermittent errors. It was discovered that the switch behind the Courthouse's perimeter firewall was going bad. The switch was not in a state where it had failed completely, but was injecting errors into Internet traffic that was affecting large downloads or file transfers. The switch was replaced and Internet functionality will be monitored to ensure the issue is resolved.

The IT Director continues to collect the needed files for the State's IT audit of several Morgan County government offices. The offices being audited are the IT office, the Auditor/Treasurer's office, the Recorder's office, the Clerk of Court's office, and County Court.

Two County vehicles were placed on GovDeals for auction to the public.

MORGAN COUNTY, OHIO LOCAL EMERGENCY PROCLAMATION

Date	February 25, 2019

AUTHORITY

Whereas, Morgan County has suffered from an excessive rainfall and flooding event that occurred between February 5, 2019 and February 13, 2019, and;

Whereas, this event caused flooding in various areas of the County which damaged multiple County, Township and Village roadways, endangering the health and safety of the residents of Morgan County, and;

Whereas, all locally available public resources available to mitigate and alleviate the effects of this disaster are insufficient to meet the needs of the situation.

Now, therefore, we, the Morgan County Board of Commissioners, declare that a state of emergency exists in the County and that we hereby invoke and declare those portions of the Ohio Revised Code which are applicable to the conditions and have caused the issuance of this proclamation, to be in full force and effect in the County for the exercise of all necessary emergency authority for protection of the lives and property of the people of Morgan County and the restoration of local government services with a minimum of interruption.

Furthermore, the Morgan County Commissioners will execute for and on behalf of Morgan County, the expenditure of emergency funds from all available sources, the invoking of mutual aid agreements, and the requesting of assistance from the State of Ohio.

Reference is hereby made to all appropriate laws, statutes, ordinances and resolutions, and particularly to Section 5502 of the Ohio Revised Code.

All public offices and employees of Morgan County are hereby directed to exercise the utmost diligence in the discharge of duties required of them for the duration of the emergency and in execution of emergency laws, regulations, and directives-state and local.

All citizens are called upon and directed to comply with necessary emergency measures, to cooperate with public officials and disaster services forces in executing emergency operation plans, and to obey and comply with the lawful directions of properly identified officers.
