Discussed Cellebrite cell phone exploitation software with Juvenile Court and the Sheriff's office. Juvenile Court is interested in the software as more and more of their cases involve cell phones.

There is a minor issue with the Court's CourtView 3 (CV3) servers in that after a remote desktop session, the console login screen stays black and unresponsive, as if the remote session is still active. The issue is intermittent and troubleshooting is ongoing.

JFS and Juvenile Court are hosting a class on 13 June 2019 at the Opera House in McConnelsville pertaining to active shooter situations. The class is focused on school settings, but the IT Director will attend the class as part of the continuing education requirement for the County's Safety Committee.
