The bid proposal for a new phone system for the Riecker Building, Sheriff's Office, and Courthouse is almost complete. When finished, it will be sent to the Prosecutor's Office for review.

Problems with the HVAC system in the Riecker Building continue. The building control unit (BCU) does not appear to be communicating with the air flow valves or heating elements throughout the building, causing temperatures to vary wildly from office to office. All attempts to restore normal functionality have been exhausted and a service call as been placed. Troubleshooting is ongoing.

While placing an order for parts on Amazon, the County's corporate line of credit appears to have disappeared from the list of available payment options. The IT Director will investigate the issue as time permits.
