Whereas, bicycle tourism is a growing industry in North America, contributing \$47 billion a year to the economies of communities that provide facilities for such tourists; and

Whereas, the American Association of State Highway and Transportation Officials (AASHTO) has designated a series of corridors crossing Ohio to be developed as various US Bicycle Routes.

Whereas, the Ohio Department of Transportation has designated a series of corridors crossing Ohio to be developed as various State Bicycle Routes.

Whereas, the Ohio Department of Transportation is supportive of AASHTO designated bicycle routes through Ohio, subject to ongoing collaboration with affected jurisdictions to inventory, analyze, and designate specific facilities the routes will traverse, and

Whereas, the Morgan County Commissioners_and the Adventure Cycling Association, with the cooperation of the Ohio Department of Transportation and other stakeholders, have proposed specific routes to be designated as various US and State Bike Routes, a map of which is herein incorporated into this resolution by reference, and Whereas, we have investigated the proposed route and found it to be a suitable route, and desire that the route be designated so that it can be mapped and signed, thereby promoting bicycle tourism in our area,

Whereas, we acknowledge the route may change over time because new facilities are being constructed that are more suitable for bicyclists,

Therefore let it be Resolved, that the Morgan County Commissioners hereby express its approval and support for the development of various State and US Bike Routes, and requests that the appropriate officials see to it that the route is officially designated by AASHTO. Once the Route is approved by AASHTO, there may be efforts to publicize the route via internet maps, incorporating the Route on local maps, etc. Tourism agencies may be involved in these efforts.

Wendy Gorrell, MCDD

-Mrs. Gorrell was seeking clarification on Help Me Grow funds that were once in the Health Department funds and were moved to DD. The commissioners let her know that they have no control over those funds. The commissioners explained to Mrs. Gorrell issues they support the work being done by DD to assist families implemented by Help Me Grow.

Gene Watkins, RAJCO

-Rajco LLC is a company that can help clients save money on utility bills. Initially, Rajco will need two years worth of bills and a month worth of energy in order to audit them. The commissioners advised Mr. Watkins this could take some time . The phone bill is what the commissioners have chosen first to begin with since it doesn't require such an extensive amount of bills. Commissioners sent the contract with RAJCO to Prosecutor Howdyshell for review.

The problems with the Riecker Buildings HVAC system continue, despite an attempt to reset the individual air valve boxes in some of the affected offices. The building control unit (BCU) appears to be the source of the problem, though no solutions have been found at this time. To add to the problems, one of the compressors on air conditioning unit RTU-2 has failed. Advanced Heating and Cooling will return to get RTU-2 online again and continue troubleshooting the BCU issues.

There is a new round of malware making its way to the e-mail inboxes of County employees. Fortunately, the antivirus software is catching the malware prior to infection. However, there appears to be several files that attempt to install with this strain of malware and it causes the antivirus software to display 30 plus pop-up windows that the user will have to close individually.

Verizon reported high data usage on the CradlePoint wireless access points in use by Public Transit. Investigations into the high usage revealed that Transit employees were connecting their personal cell phones to the CradlePoints while at work. Steps to resolve this issue are in discussions.

While it was thought that the County's Amazon corporate line of credit had been removed from the County's Amazon account, it turns out that it will merely disappear if an item that cannot be purchased with a corporate line of credit is in the shopping cart. Once the offending item is removed from the cart, the line credit will return as a method of payment.
