This meeting doubled has the annual awards ceremony; Morgan County received an award for having lowered the amount of hours taken off due to injury or illness over 2018. The safety meeting was about ways

to make safety fun in the workplace and seemed to be geared towards businesses that have a full time Safety Officer.

With a steady supply of critical Windows zero-day vulnerabilities being made public, it is more crucial than every to make sure that operating system updates are being performed. The IT Director ensured that updates were performed on critical systems and will attempt to go office by office and get all computers updated.

An important update was completed on one of the firewalls used by the County. The upgraded software adds some new built-in features that were originally add-on extras, such as an intrusion prevention systems (IPS). The IPS software appears to be lighter on resources than the original IPS add-on. Resource usage and logs on the test firewall will be monitored.

Phone bids were opened and read in the Commissioners' Office on Tuesday, 28 May 2019. The IT Director will now look at the proposals and discuss the results with the Commissioners to determine which proposal will be the best fit for Morgan County's various offices.
