\*Engineer Hook wanted to know if the commissioners had heard of any issues or knew of any. Commissioner Shriver commented on CR 17 (Lick Run Road) and the paving being done on that road. Morgan County resident Troy Riley addressed the engineer about horrible county road conditions on roads that he travels. Mr. Hook replied that he was under staffed and short on budget dollars to address all road conditions but that he and his employees did the best they could do under extremely wet conditions.

***Jeff Babcock, IT Administrator***

-McConnelsville had two brief power outages on 14 and 17 June. The outage required two of the three main AC units in the Riecker Building to be reset as well as the phone system. A monitor in the Auditor's failed following the outage causing the appearance of a boot issue on the connected PC. Additionally, several firewalls in the Riecker Building were offline following the outage and had to be reset.

The IT Director attended a class on 13 June 2019 to satisfy the training requirement by Bureau of Workers Compensation for the County's Safety Committee for the year. The class was called "Why Teens Kill" and addressed active shooter situations. Though mostly focused on school shootings, some lessons could be applied to the workplace.

The long-standing issue with changing e-mail passwords in Outlook as been resolved. With HostGator e-mail accounts, passwords cannot be updated in the Account Settings section of Outlook, as one would expect to do. Instead, the password needs to be updated through the e-mail profile settings.

The Ohio Secretary of State has set a new requirement on the Board of Elections (BoE). All e-mail accounts used by BoE workers must be on the .gov or .us domains. E-mail accounts were created on the County's mail server to satisfy this requirement.
