- The long distance issues on the County's T1 lines from CenturyLink appear to have been resolved. After discussing the recent issues (over-charging on long distance and incorrect long distance carrier) for the T1 lines with our account manager, CenturyLink set the long distance PIC code for First Communications on both T1 lines and agreed to reissue the recent bills with corrected long distance charges.

The IT Director went to the Morgan County Health Department to set up system and data backups on the computers. Three of the computers need to have full system backups run daily as they host databases that cannot be easily replaced (Infall, HDIS, and Tokay). All computers will have data backups set up so that users will have their documents and other files saved in the event of a computer hardware failure.

Poynters returned to install the new workstations, server, and network infrastructure for the Board of Elections (BoE). Three of the network connections in the patch panel had to be redone as they were wired as crossover. Poynters needed several ports forwarded through the Riecker Building perimeter firewall for remote access by the BoE vendors. The Secretary of State's office sent one of their officers to oversee the installation and verify all the items of their security directive was being properly implemented.
