-The IT Director continued working with the Board of Elections (BoE) while they move towards completing the Secretary of State's cybersecurity directive. Poynters completed the new server and workstation installations and provided a brief overview of administrative functions. Work is still in progress on several subsections of the directive; such as moving the BoE website to a .gov domain and setting up DDoS protection.

Work has begun on a new webpage for the Board of Elections (BoE). The Board of Elections' website will need to be moved to a .gov domain by the end of January 2020 to satisfy the Secretary of State's cybersecurity directive. The BoE website has a lot of information, so this move presents an opportunity to change the formatting and add missing features.

While attempted to transfer control of the County's HostGator account to the Commissioners' office, DJH Computers discovered that the County's domain registrar is not HostGator, but DotGov.gov. The IT Director contacted DotGov.gov to set up an account and get added to site management. However, given the time that has passed since the .gov domain was registered, it is possible that the previous e-mail contacts are no longer valid.

The computer used for the Infall billing program at the Morgan County Health Department failed at opening of business on 10 Jan. 2020. The computer only presented options for repairing the Windows 10 installation upon boot up. The IT Director contacted Infall to see which directories needed to be backed up to save the Infall database. Unfortunately, the directory would not copy to a backup disk; the Infall log file failed to copy. Troubleshooting is ongoing.

Two firewalls had failed at opening of business on Monday, 13 Jan. 2020. The Engineer's firewall failed and had to be rebuilt. The firewall for Common Pleas Court was down, but was returned to operation following a reboot.
