Jeff Babcock, It Administrator

Work continues on the repair of users' e-mail client server settings. Utilizing the Athenian Project by Cloudflare caused the County's mail server shortcut name to stop working. The individual e-mail clients need to be updated to reflect the mail server's actual name.

Two vehicles from the Sheriff's office and the County's old phone systems were added to the GovDeals website for auction.

It appears that CenturyLink did not set up the Treasurer's fax number on the Riecker Building T1 line in October when the other T1 line was moved to the Sheriff's office. CenturyLink has been contacted to fix the issue.

Network interface hardware problems might be causing Internet slowness on County networks. It was discovered that the on-board network interface cards (NIC) on the phase 2 firewall hardware appears to have higher rate of failure than the rest of the hardware in the PC. Failure of these NICs starts in the form of slower Internet. Therefore, phase 2 firewalls will be rebuilt using add-in NICs only to see if this alleviates the slowness.
