**THEREFORE, BE IT RESOLVED,** that the Board of County Commissioners, Morgan County, Ohio, does hereby authorize Stevan Hook, Morgan County Engineer to use the existing county employee forces and proceed by "Force Account" as outlined in Section 5543.19 of the Ohio Revised Code, in the maintenance, repairs, construction of roads, bridges, and culverts in Morgan County during the year 2020; and,

**BE IT FURTHER RESOLVED,** that the Morgan County Commissioners reserve unto themselves the right and authority to make all purchases of material and equipment required in the maintenance, repairs, construction of roads, bridges, and culverts in Morgan County during the year 2020, except that as the Board may from time to time by resolution designate such purchasing to Stevan Hook, Morgan County Engineer; and,

**WHEREAS**, the Ohio Revised Code Section 153.64, 4931, 4933, provide to the Board of County Commissioners, the authority to control the installation and placement of any public utilities within the dedicated public right-of-ways of all County maintained highways; and,

**WHEREAS**, the Ohio Revised Code Section 5589 and 5543 provides to the Board of County Commissioners, the authority to control any digging and excavating on or along a County maintained highway; and for the placement of a private driveway approach to a County maintained highway; and,

**WHEREAS**, the Ohio Revised Code Section 4513.34 provides to the Board of County Commissioners, the authority to permit oversize and overweight vehicles using County maintained highways.

**THEREFORE, BE IT RESOLVED that** the Board of County Commissioners, Morgan County, Ohio, does, hereby authorize Stevan Hook, Morgan County Engineer to develop and administer permits for the above described activities within County road right-of-ways and to keep said permits with the permanent road records of Morgan County.

# Jeff Babcock, It Administrator

- The Morgan County Board of Elections is now 100% compliant with the Ohio Secretary of State's 2019 Cybersecurity Directive. There were a couple of smaller issues that had to be resolved first. The primary issue was that the Albert sensor (intrusion detection system) on the BoE network was not communicating to the State. After much troubleshooting, it was determined that the Albert sensor was connected via the wrong port; the installation directions provided by the State were incorrect.

While investigating the on-going billing issues with the County's long distance provider on the main phone lines, it was conveyed that both of the CenturyLink account managers the County had been working with have moved on to other jobs. A temporary account manager is assisting the County with resolving the long distance issues.

The on-board network interface card of the Engineer's internal firewall failed causing a network outage for the Engineer's office. The firewall was rebuilt using only add-in network interface cards and the network was restored. All firewalls will eventually be rebuilt using only add-in network interface cards to prevent this type of outage in the future.

The on-going test of Windows Defender as a primary antivirus program continues successfully. Windows Defender appears to be performing as good as other free antivirus programs, but does not drain system resources (of particular importance to old computers). The IT Director's office will next identify several users throughout the County that can test Windows Defender on their workstations. Eventually, free antivirus software will be removed from all County workstations.

A new page was created for the County's website for the 2020 Census and what it means to Morgan County. The page has links to the main 2020 Census website that discuss how accurate Census numbers affect public funding for a variety of projects that Morgan County relies on. The Census documents should start arriving via the mail on March 12 - 20, 2020.
