The Morgan County Board of Elections has no serious cybersecurity issues that require immediate action. Remediation of the two medium level vulnerabilities is ongoing.

Surveillance cameras were installed in the Board of Elections' office to satisfy new physical security requirements levied by the Secretary of State. The cameras will monitor several areas of the Board of Elections office as well as the exterior of the building on a 24 hour basis.
