-While adding and removing e-mail addresses from the mail server, several addresses were found to still be active for the Commissioners' office. While all of them can be deleted, it might be prudent to backup a couple of the addresses as they may contain information that needs to be retained.

The endpoint detection and reporting (EDR) tool, Falcon from Crowdstrike, was installed on all workstations and servers in the Morgan County Board of Elections. This installation was required to satisfy a cybersecurity directive from the Secretary of State.

It appears that all the Zanesville – Muskingum Safety Council meetings are going to be virtual this year. As such, the BWC will not be offering their 2% discount for attending all of Safety Council meeting for this fiscal year.

Public Transit purchased and installed a new temperature sensor, similar to the one installed in the Sheriff's office. The sensor employs facial recognition as well as infrared temperature sensing to scan employees as they approach the time clock. It can detect if an employee is wearing a mask and can be linked to automated doors to allow or deny access. The sensor can produce a wide variety of reports as well. This feature will be tested once some more data has been input into the sensor.
