-Vince from Poynters returned to fix an issue with remote logins in the Board of Elections. The issue was apparently caused by the RSA server not communicating with Active Directory. The issue was fixed while troubleshooting with no clear resolution. The fix was likely an expired password on one of the RSA accounts.

Work continues on the IT Director's Windows 10 PC in the NOC. The PC has a hardware issue that causes it to reboot at random times; possibly related to heat or power. The random reboots have messed up the Windows update system folder and make it difficult to test new software. The power supply was replaced and the PC appears to be operating normally.

Voicemail was set up on the phone lines at Public Transit. In the past, voicemail was not really needed as staff was usually in the building to receive calls. However, due to COVID restrictions, there are more calls coming in after-hours that require action. Voicemail is included with all Spectrum phone lines at no additional cost.

When ordering supplies for County offices, the IT Director will start flagging orders that use CARES money when applicable.
