-First Communications, the County's long distance provider, experienced a major outage this week. The County was without the ability to call long distance for about 6 hours on 8 December 2020. Service was restored after close of business on 8 December 2020.

Work continues with Citizen's National Bank to find a method for transmitting financial information securely from the Treasurer's office. Several methods of encrypting files were tested, but the bank is not able to install any new software on their computers and their e-mail

server rejects self-extracting, encrypted archives.

A technician from Spectrum stopped in to survey the Riecker Building for fiber availability. Spectrum is working on a quote for PRI lines to the Riecker Building and Sheriff's Office.

Advanced Heating and Cooling returned to perform their semiannual cleaning and servicing of the Riecker Building's rooftop AC units. The AC units were in good shape and relatively clean. The only issue was with a frayed belt on an exhaust fan, which was replaced.

The cameras for the back parking lot of the Riecker Building were mounted on the top of the building. Cabling was ran from the cameras to the surveillance wiring closet on the second floor. The cameras were connected and appear to be working fine, they just need slight adjustments.

With the end of the year approaching, many offices are putting in COVID-related supply orders utilizing the State's CARES funding.

County Appropriation: \$3,500.00

Goals for 2021:

- Maintain Morgan SWCD office in Morgan County
- Continue educational events for youth and adults
- Bring employees up to 40 hours a week and provide health care benefits
- Purchase additional equipment to rent to the producers in Morgan County

Educational events for 2020 that got cancelled because of COVID-19:

- All Field Days; Hook Lake, and 4th Grade
- Beginning Farmers Bus Tour
- Tree sale; it was our biggest tree sale to date
- Fish sale with a drive through to keep in regulations of COVID-19
- Fair Booth
 - We set up our Fair Booth up in the hallway with our photo and poster contest with 59 photos with 180 votes and 17 posters with 32 votes

How important the office was this year with COVID-19:

- The SWCD maintained a person in the SWCD throughout COVID-19 to provide a contact person for Morgan County Producers
- This provided a continuous connection for producers as the federal programs moved forward with deadlines
- Morgan SWCD staff assisted with information, questions, and help with contacting OSU Extension office for Morgan County Producers, since their office closed in March
- Morgan SWCD continues to be point of contact for producers for guidance on upcoming programs

Other Entities we work with:

- Morgan County Auditor's Office
 - District tech and Auditors office worked together on 43 CAUV Applications
 District tech made visits to determine if the application is actively farming the land in CAUV
- Morgan County Engineers office
 - Continues to work with the SWCD Office in support of the Spotted Knapweed Program in trying to control the invasive species along county roads
- Morgan County ODOT
 - Continues to work with the SWCD Office in support of the Spotted Knapweed Program in trying to control the invasive species along state highways
- Morgan NRCS
 - Total Payments made to Morgan County Producers for installation of practices: \$387,029
 Environmental Quality Incentive Program (EQIP)- \$353,942 for 135 practices applied
 Conservation Stewardship Program (CSP)- \$12,175 for 4 annual payments
 Regional Conservation Partnership Program (RCPP)- \$20,912

Things we do to keep our Producers and Farmers in the County up to date:

- The Morgan SWCD creates, prints, and mails out 850 newsletters
- The bi-monthly informational newsletter provides Morgan County landowners with educational events for both the Morgan SWCD and the Morgan County OSU Extension

Equipment and Filter Fabric:

- The repairs of the equipment come from the income from the rental equipment
 - This equipment provides an average of 30 producers with equipment to use that don't have the money to purchase their own
- The SWCD provides a John Deere Gator and Sprayer free of use to the producers that is in the R.C.P.P. program
- Geotex Filter Fabric, which is used with installation of a variety of practices
 - o Morgan SWCD has provided 148,500 square feet of filter fabric for practices

Support:

- The Morgan SWCD has an outstanding Affiliate Membership program, where the community donated \$2,775.00 in 2020 to help support Morgan SWCD and programs
- To assist with the bi-monthly newsletters, individuals or businesses can opt to purchase an ad, this year we had 14

Concerns:

- The Morgan SWCD continues to strive to find finances to have educational events and maintain the office
- AEP has been a strong supporter for educational events, but due to office closure and land sale, the financial support is no longer available to the 600 kids

Budget and Expenses:

- We lost our leasee due to COVID-19, so we are paying all utilities with no income
- To maintain the office and staff it takes \$47,000 a year, with \$40,000 coming from the State of Ohio and Morgan County Commissioners
