Advanced Business Communications worked with the IT Director to set up the unified communications (UC) mobile application. The requisite ports were opened on the firewall to accommodate the UC application. However, it was discovered that the mobile application used random ports to connect to the phone system. This prevented mobile UC accounts from connecting to the PBX. Troubleshooting is ongoing.

The IT Director continued to clean up the old computer hardware in the network operations center. The excess hardware is being used to build new remote access workstations for the various County networks, allowing additional firewall hardware to be reclaimed.
