- Spectrum upgraded the Internet connection at the Riecker Building on 2 June 2021 from 200 Mbps/10 Mbps to 600 Mbps/35 Mbps. Unfortunately, the new modem and speed required the installation of a dedicated router (provided by Spectrum) in order for the Riecker Building to keep its static IP address. The new router does not work with the existing perimeter firewall at the Riecker Building. The built-in firewall was configured on the Spectrum router to get the Internet connection secured. However, incoming connections from other locations will need to be reconfigured. Attempts to get the old perimeter firewall running again is ongoing.
