- The static IP issue on Spectrum's new Internet router at the Riecker Building has been resolved. The more secure perimeter firewall has been placed back online and is once again able to control remote access to the Riecker Building's network.

On June 22, 2021, the Riecker Building experienced a power anomaly in that one phase of the three phase power coming into the building was about 20 to 30 volts too high. The excess voltage caused issues with the lighting in the Riecker Building and may be responsible for some HVAC issues experienced in certain offices.

Microsoft announced the replacement to Windows 10: Windows 11. Windows 11 will have much stricter hardware requirements, so it is doubtful that any of the existing hardware will be able to update to Windows 11. Also, during a clean installation, a Microsoft account is now required for setup. It is unclear as to whether local user accounts can be created after that or not.
