Sophia Whisman, 4—H Educator

March: She attended Senior Fair board, Junior Fair board, 4—H Advisory Committee, and junior Leaders/Older Youth in Training meetings. She volunteered to participate in the real money real world simulation for Washington County at Waterford High School to learn more about the program. She attended an in-person Onboarding session in Columbus.

April: She had a performance review with my supervisor Pam Montgomery. She held a program at the Kate Love Simpson Library for Egg Embryology with Chris Penrose had about 25 kids and adults in attendance, have had positive feedback from the event. She had the first Cloverbud STEM Day “Swing into Spring” they did spring related activities ran by my Older Youth in Training and Junior Leaders had about 19 kids in attendance and six older youth. She co-led an Older Youth in Training, Junior Leaders, Camp Counselors and Camp Counselors in Training workday with Pam Montgomery. To date, she has attended Extension Advisory, Junior Fair board, Senior Fair board, meetings. Will visit my mentor Jamie McConnel on the 17th in Muskingum County where she is the 4—H Extension Educator. She plans to attend a REACH training in Belle Valley on the 21st.

Betsy Ellingsworth, the SNAP—Ed Program Assistant

She is currently offering a series of nutrition programming with kindergarten—4th grade students at Morgan West Elementary. On March 28, she had a family fun night at Morgan East Elementary for the afterschool families where there was a large group of adults and children to activity participate in nutrition stations to learn about my plate, whole grains, how to read nutrition labels, and make healthy food choices. Each family was provided a take home bag full of ways to put into practice all they learned. She recently finished a series at Mary’s House to help new moms out there with their how to grocery shop and prepare snacks and meals for their children. At the senior center, she is offering a Meals in a Mug series to help seniors create healthy single portion meals using mugs and microwave cooking. On April 5, Betsy went to the food distribution sites in Stockport and Chesterhill and on April 12 to Malta to hand out recipes

that were geared to items given in commodity boxes and tips for how to handle, store, thaw and prepare ground beef. She finished meetings this past month with community partners to plan programming throughout the spring, summer and into fall and to complete necessary grant work for the next year. She and Pam Montgomery went to the FCFC meeting on April 14, where Betsy presented to the group about the topics taught in SNAP—Ed programming. On April 15 she participated in the Community Baby Shower with multiple community partners to support expecting a new moms by providing them with nutritional educational handouts and recipes. Betsy continues her 16—week course, Navigating for Success, with other new SNAP—Ed professionals throughout the state, as she travels to Columbus once a week.

In the past month, Chris taught two ATV/UTV Safety classes. He also taught and facilitated a meeting with 60 producers with area veterinarians on the upcoming changes for antibiotics for all animals. A weed identification program was provided to Master Gardeners, and he taught a lawn program to Master Gardeners in Muskingum County. He was also a guest lecturer for a Small Animal Ruminant Nutrition class at OSU. Chris and Sophia also provided an Egg releases to the Morgan Co.
